



**Directions:** From the North side of Bazine, Ks at the junction of Hwy 96 & Main St. South - Now go 0.7 mile South & SE on Main St. - Now go 0.3 mile West on Repine Ave - Now go 8.3 miles South on S DD RD - Now go 5 miles East on 40 RD to the NW corner of section 13-20s-21w - Now go 0.5 mile on East on 40 RD to ingress stake South into - Now go approx. 140' South through wheat - Now go approx. 335' on South through grass waterway - Now go approx. 525' on South through wheat stubble to ingress stake SE into - Now go approx. 1215' SE along terrace through wheat stubble into staked location.
