- 5. The appropriate district office will be notified before well is either plugged or production casing is cemented in;

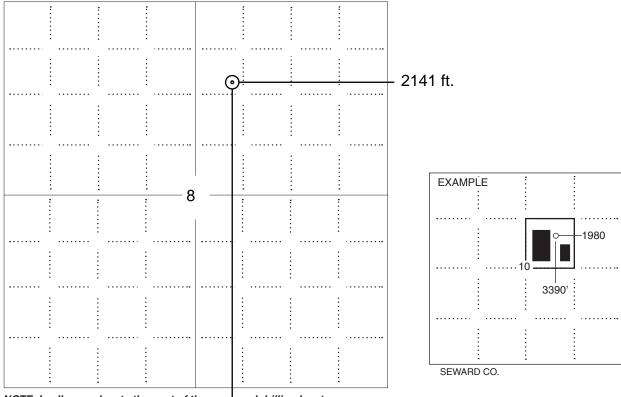
