- 5. The appropriate district office will be notified before well is either plugged or production casing is cemented in;

Or pursuant to Appendix "B" - Eastern Kansas surface casing order #133,891-C, which applies to the KCC District 3 area, alternate II cementing must be completed within 30 days of the spud date or the well shall be plugged. 
