AFFIDAVIT

The undersigned hereby affirms that the drilling, completion and eventual plugging of this well will comply with K.S.A. 55 et. seq.

It is agreed that the following minimum requirements will be met:

1. Notify the appropriate district office **prior** to spudding of well;
2. A copy of the approved notice of intent to drill **shall be** posted on each drilling rig;
3. The minimum amount of surface pipe as specified below **shall be set** by circulating cement to the top; in all cases surface pipe **shall be set** through all unconsolidated materials plus a minimum of 20 feet into the underlying formation.
4. If the well is dry hole, an agreement between the operator and the district office on plug length and placement is necessary **prior to plugging**;
5. The appropriate district office will be notified before well is either plugged or production casing is cemented in;
6. If an ALTERNATE II COMPLETION, production pipe shall be cemented from below any usable water to surface within **120 DAYS** of spud date. Or pursuant to Appendix "B" - Eastern Kansas surface casing order #133,891-C, which applies to the KCC District 3 area, alternate II cementing must be completed within 30 days of the spud date or the well shall be plugged. **In all cases, NOTIFY district office** prior to any cementing.

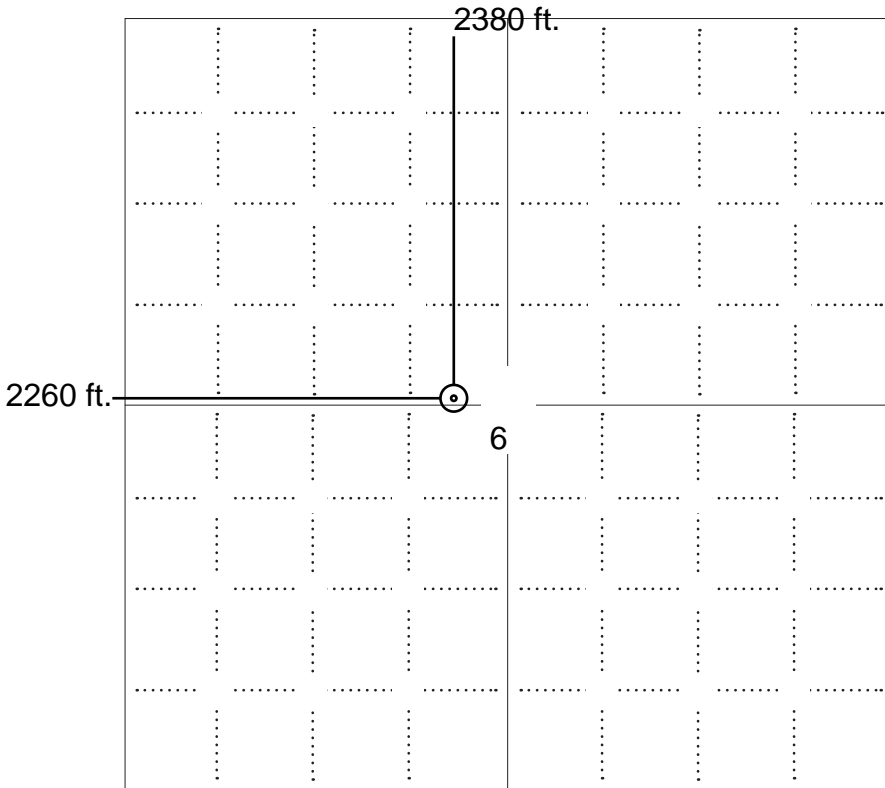

DECLARATION OF UNITIZATION

WHEREAS, the undersigned, Baird Oil Company, LLC, is the operator of the following described Oil and Gas Leases, to-wit:

Oil and Gas Lease dated January 9, 2010, from Gene L. Schemper, a single person, as Lessor, to Baird Oil Company, LLC, as Lessee, recorded in book 163A, pages 486 et seq. in the office of the Register of Deeds in Norton County, Kansas,

Tract 2. The Northwest Quarter (NW/4) of Section 6, Township 4, Range 21, Norton County, Kansas;

Oil and Gas Lease dated August 1, 2008, from Sherlyn B. Kats and Irene F. Kats, his wife, as Lessors, to J. Fred Hambright, Inc., as Lessee, recorded in book 156A, pages 204 et seq. in the office of the Register of Deeds in Norton County, Kansas,

Said lease covering the following described land, to-wit:

"Lessee, at its option, is hereby given the right and power to pool or combine the acreage covered by this lease or any portion thereof with other land, lease or leases in the immediate vicinity thereof, when in lessee's judgment it is necessary or advisable to do so in order to properly develop and operate said lease premises so as to promote the conservation of oil, gas or other minerals in and under and that may be produced from said premises, such pooling to be of tracts contiguous to one another and to be into a unit or units not exceeding 40 acres each in the event of an oil well....."

WHEREAS, said Lessors have executed an Amendment to Lease allowing Lessee to pool a unit or units not exceeding 82 acres each in the event of an oil well.

WHEREAS, the undersigned intends to pool the acreage covered by the above described Oil and Gas Leases to form a unit consisting of approximately 80.75 acres and being described as:

A unit of approximately 80.75 acres in Section 6 beginning at a point on the East Section Line of Section 6, said point being 2050 feet South of the North Section Line; thence due West parallel to the North Section Line to a point, said point being 2050 feet South of the North Section Line and 3350 feet West of the East Section line; thence South parallel to the East Section line 1050 feet to a point; thence East parallel to the North Section line 3350 feet to a point on the East Section Line; thence North 1050 feet on the East Section Line to the point of beginning, in Section 6, Township 4, Range 21, Norton County, Kansas

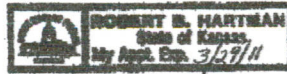

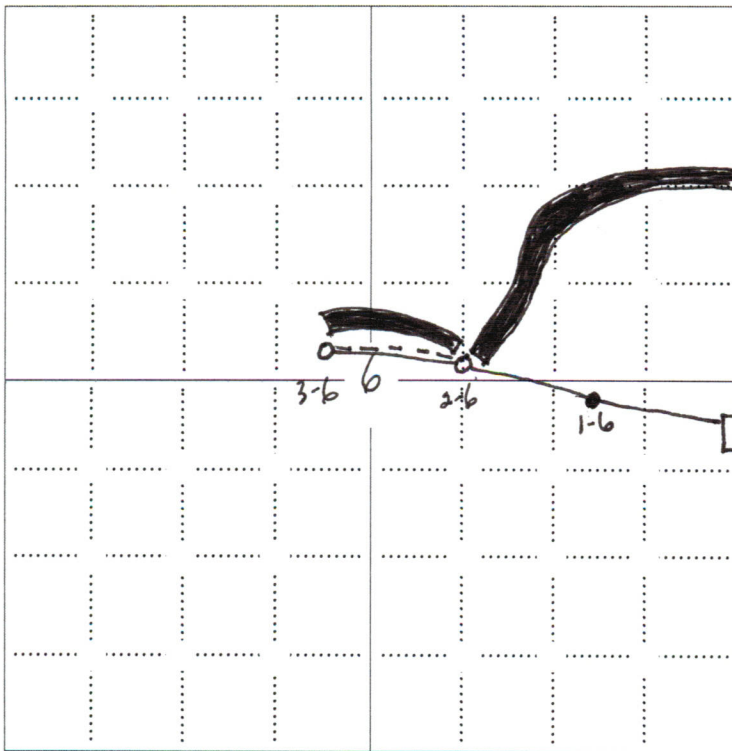

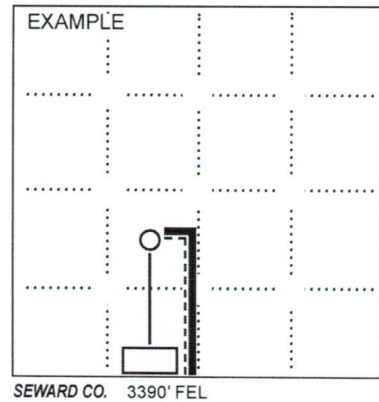
