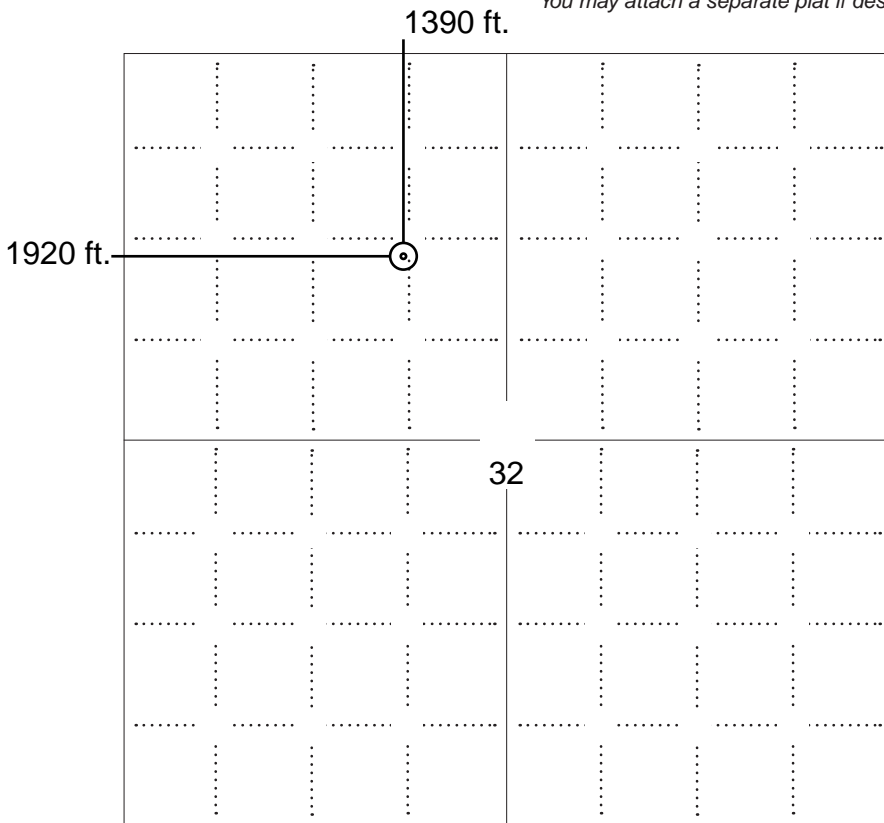

AGREEMENT, Made and entered into this day 2nd of June, 2009, by and between

PATTI K. BONNETT, a married woman

whose mailing address is 2014 SW Randolph Ave., Topeka, Kansas 66604 hereinafter called Lessor (whether one or more), and PL&H LLC, a Kansas Corporation, PO Box 23, Wahoo, NE. 68066 hereinafter called Lessee:

Lessor, in consideration of ten dollars and more (\$10.00) in hand paid, receipt of which is here acknowledged and of the royalties herein provided and of the agreements of the Lessee herein contained, hereby grants, leases and lets exclusively unto Lessee for the purpose of investigating and exploring by geophysical and other means, prospecting drilling, mining and operating for and producing oil, liquid hydrocarbons, all gases and their respective constituent products, injecting gas, water, other fluids, and air into subsurface strata, laying pipe lines, storing oil, building tanks, power stations, telephone lines, and other structures and products manufactured therefrom, and housing and otherwise caring for its employees, the following described land, together with any reversionary rights and after-acquired interest, therein situated in County of NORTON, State of KANSAS, described as follows to-wit:

TOWNSHIP 3 SOUTH RANGE 23 WEST SECTION 32: N2N2 @S2SW4 AND TOWNSHIP 4 SOUTH RANGE 23 WEST SECTION 5: NW4

In Section , Township , Range , and containing 400 acres more or less, and all accretions thereto.

Subject to the provisions herein contained, this lease shall remain in force for a term of three (3) years from this date (called "primary term") and as long thereafter as oil, liquid hydrocarbons, gas or other respective constituent products, or any of them is produced from said land or land with which said land is pooled.

In consideration of the promises the said Lessee covenants and agrees:

Where gas from a well producing gas only is not sold or used, Lessee may pay or tender as royalty One Dollar (\$1.00) per year per net mineral acre retained hereunder, and if such payment or tender is made it will be considered that gas is being produced within the meaning of the preceding paragraph.

This lease may be maintained during the primary term hereof without further payment or drilling operations. If the Lessee shall commence to drill a well within the term of this lease or any extension thereof, the Lessee shall have the right to drill such well to completion with reasonable diligence and dispatch, and if oil or gas, or either of them be found in paying quantities, this lease shall continue and be in force with like effect as if such well had been completed within the term of years first mentioned.

If said Lessor owns a less interest in the above describe land than the entire and undivided fee simple to estate therein, then the royalties herein provided for shall be paid the said Lessor only in the proportion which Lessor's interest bears to the whole and undivided fee.

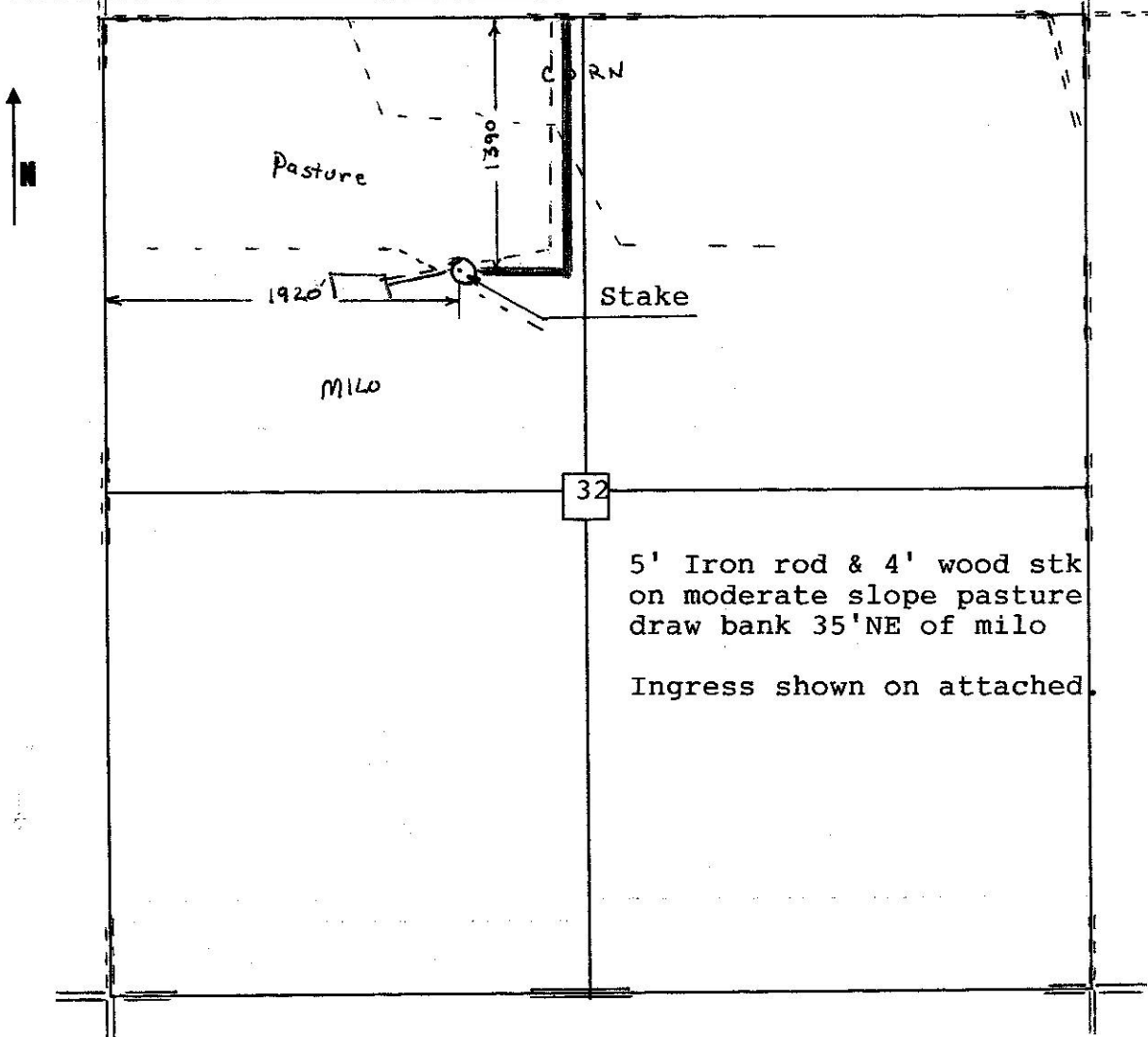
