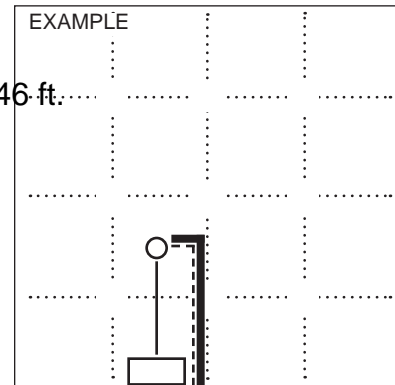

From the intersection of Highway 283 and Highway 96 in Ness City, Kansas go 7.0 miles South on Highway 283, then go 8.0 miles West on a county road to the SE. Corner of Section 35, then go 0.43 miles North to a flagged fence, then go 0.20 miles West to location.

1. Set iron rod at location site.
2. All flagging Red & Yellow.
3. Overhead power available at S. & W. lines and S. 1/4 of E. line, Sec. 35.
4. Kansas One Call System Inc. should be notified before excavation (1-800-344-7233).
