

Subject to the provisions herein contained, this lease shall remain in force for a term of <u>viii co</u> years from this date (called "primary term"). and as long thereafter as oil, liquid hydrocarbons, gas or other respective constituent products, or any of them, is produced from said land or land with which said land is pooled. 
