Directions: From the East side of Garden City Ks at the intersection of Hwy 156 & Jennie Barker Rd - Now go 16.5 mile NE & East on Hwy 156 - Now go 2 miles South on Haflich Rd to the NE corner of section 25-23s-30w & ingress stake SW into - Now go approx. 930' SW through worked corn stubble into staked location.
