Your application for Temporary Abandonment (TA) of the above-listed well is denied for the following reasons(s):

HGFLD - High fluid level
OVR10 - Shut in over 10 years

In accordance with K.A.R. 82-3-111, this well must be plugged or returned to service by September 30, 2011.

You may file an application for an exception to the 10-year limitation in K.A.R. 82-3-111 to demonstrate why it is necessary to TA the above well for more than (10) years. You must notify the Commission in writing no later than September 30, 2011 of your intention to file the application, and your complete application is due October 30, 2011. All applications and written notifications must be sent to the attention of the Executive Director at the Kansas Corporation Commission Conservation Division at 130 South Market, Room 2078, Wichita, Kansas 67202.
