REMARKS: Rig up cement head, Go over cementing Procedure. Break circulation with 12 Bbl. Dye water, Mixed 166 SKS. Quick Set cement w/ 5" KO1-SEAL. Shutdown - washout pump & lines - Release Rubber Plug. Displace Plug with 22 1/2 Bbls water. Final Pumping @ 900 PSI - Bumped Plug to 1300 PSI, wait 5 minutes. Release Pressure - Float Hold. Close casing w/ 0 PSI. Good cement returns with 10 Bbl. slurry
 NOTE: during cementing Procedure lost circulation due to well bridging off. "Thank you"
