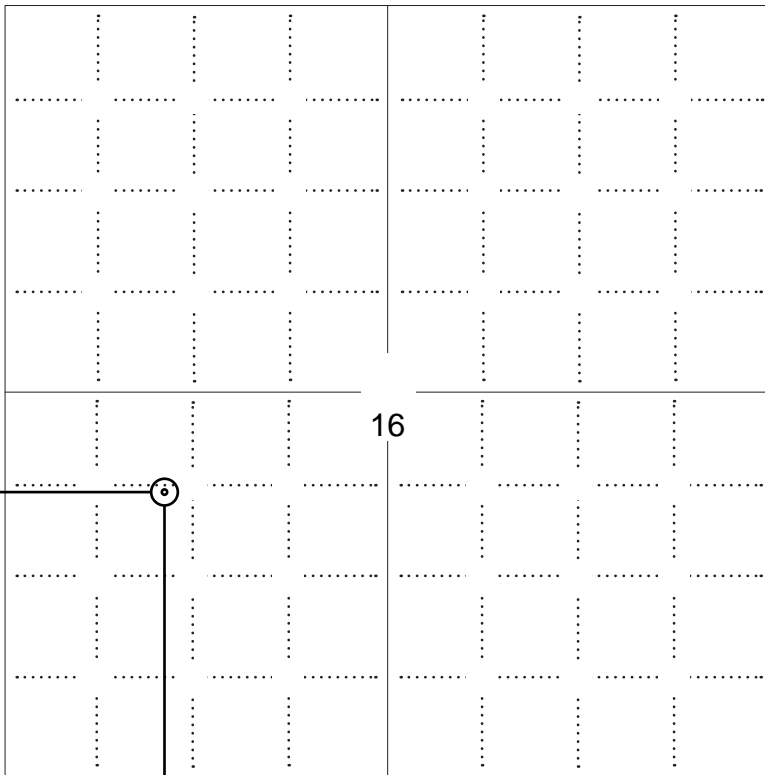

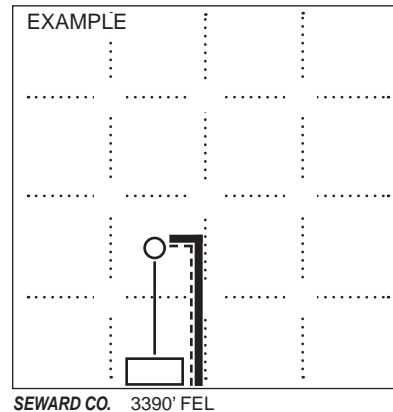

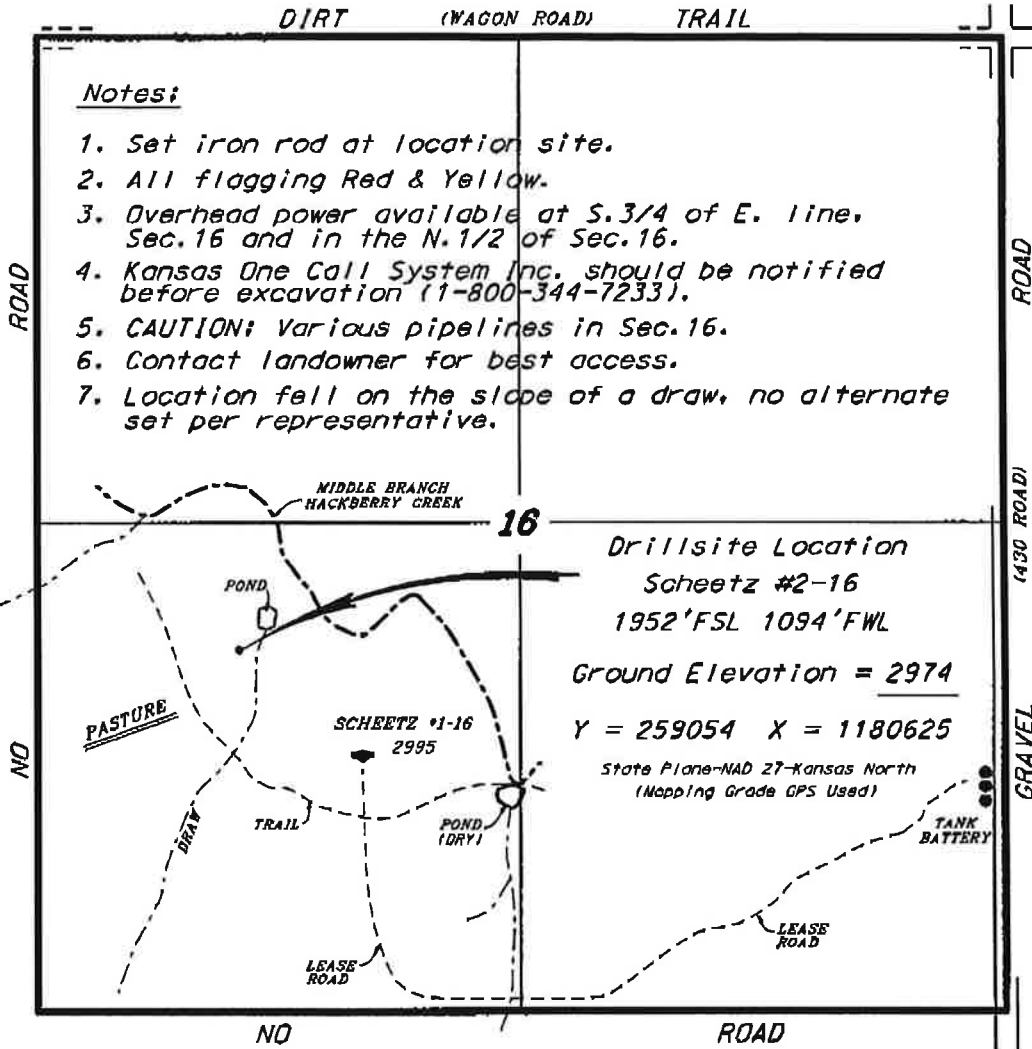

DIRT (WAGON ROAD) TRAIL

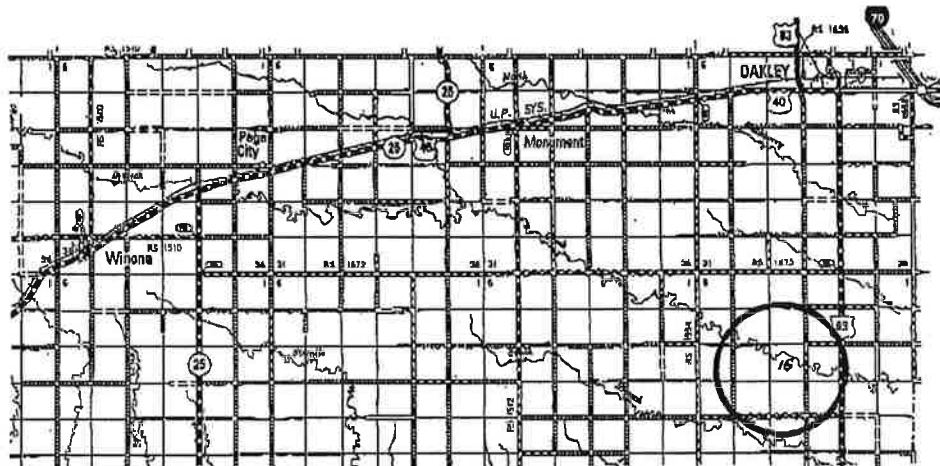
