Mix 140 sks Thick set cement w/ 5\* Koi-Seal & 1\* Phenaseal per/sk. At 12.5\*. Wash out pump & lines. Shut down. Release plug. Displace with 21 1/2 bbls fresh water. Final Pumping Pressure 700\* Bump plug 1200\*. Wait 2 min. Release pressure. Plug held. Good cement returns to surface 11 bbls to pit. Job complete Rig down.
