Subject to the provisions herein contained, this lease shall remain in force for a term of \_\_3\_\_\_ years from this date ( called "primary term"), and as long thereafter as oil, liquid hydrocarbons, gas or other respective constituent products, or any of them, is produced from said land or land with which said land is pooled.

In consideration of the premises the said lessee covenants and agrees:

1". To deliver to the credit of lessor, free of cost, in the pipe line which lessee may connect wells on said land, the equal one-eighth (1/8") part of all oil produced and saved from the leased premises.
