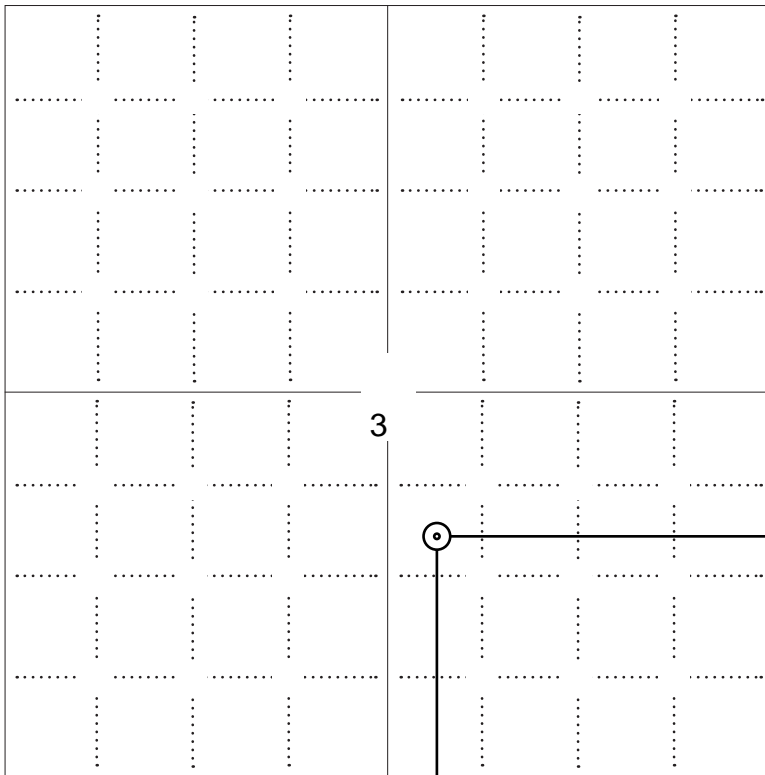

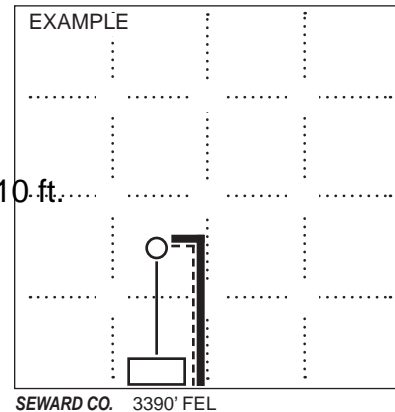

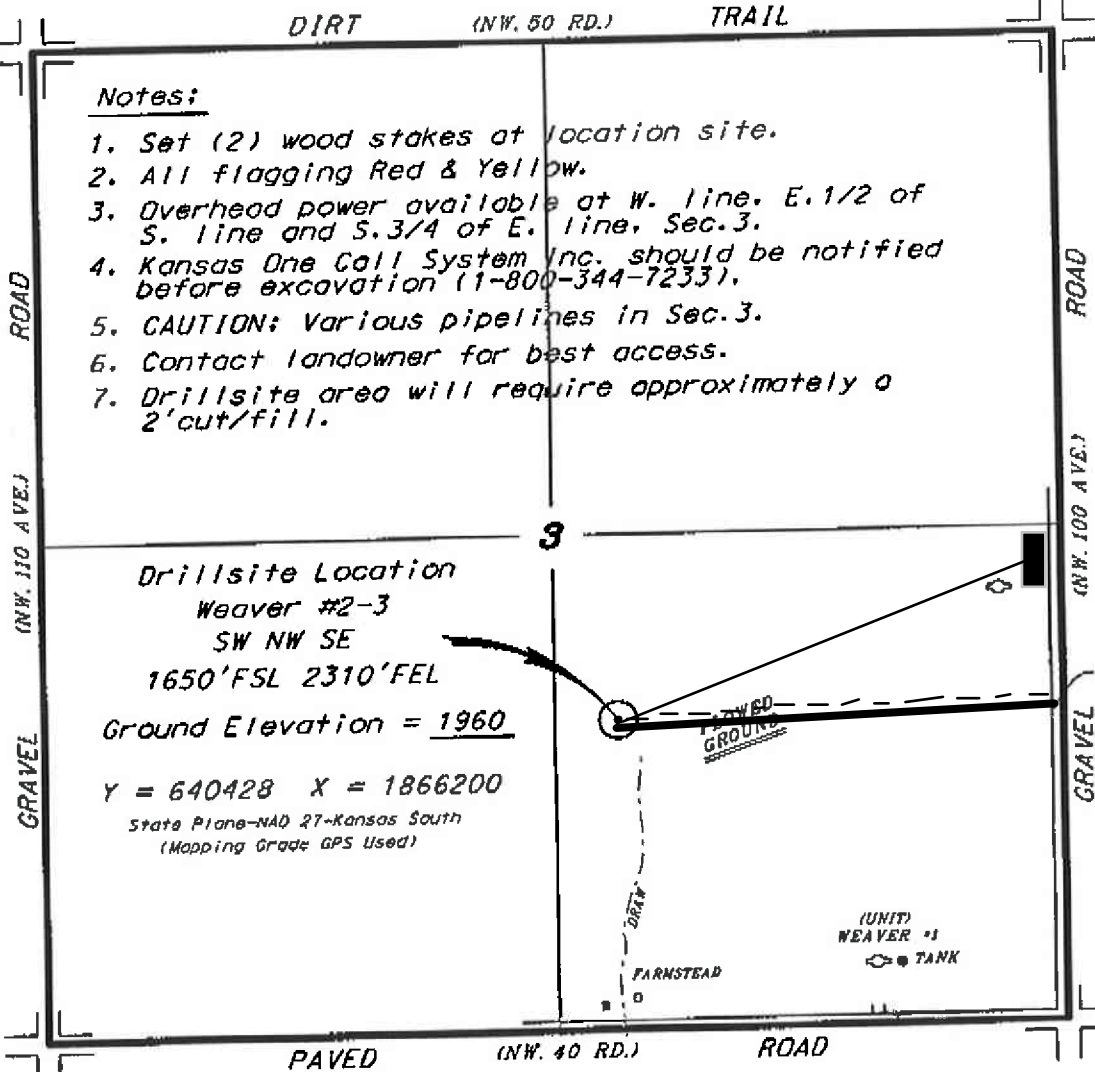

DIRT (NW. 50 RD.) TRAIL

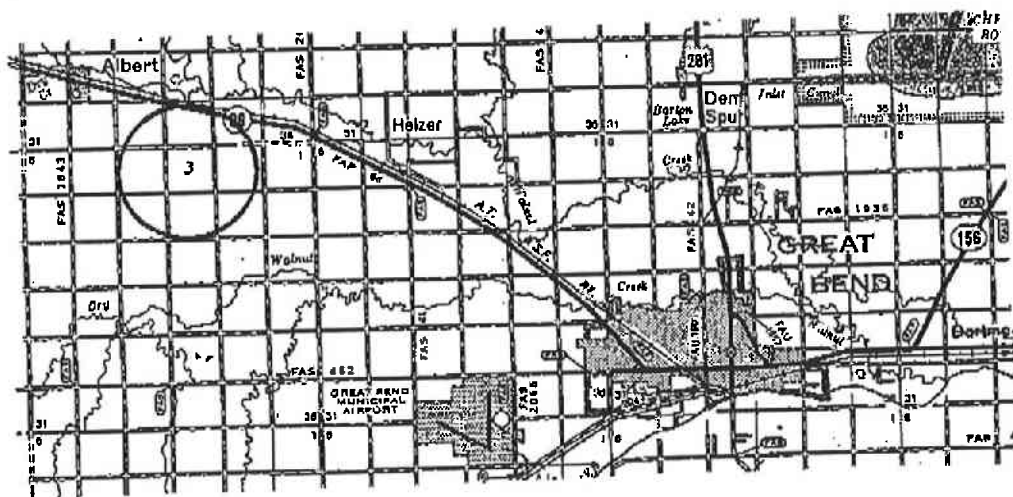
