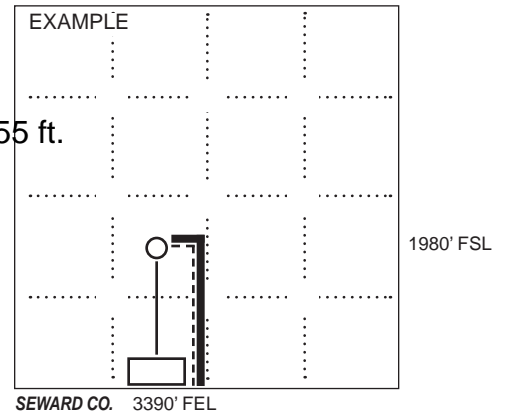

**Final ingress must be verified with land owner or Operator.**

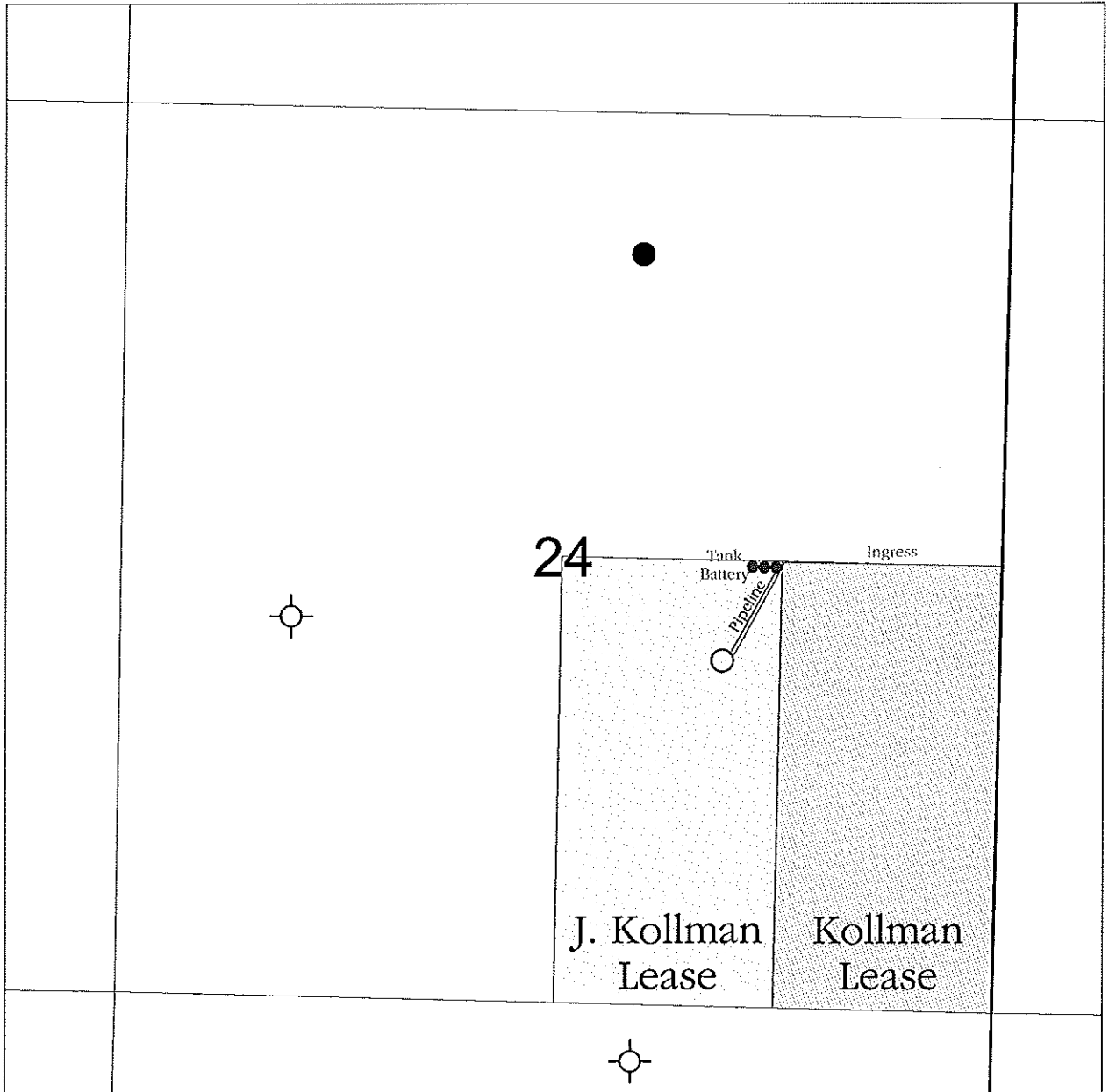
