Displace w/ 12.1 Bbl fresh water. Final pump pressure 500 PSI. Pump plug to 1000 PSI. wait 2 minutes, release pressure float & plug held. Good cement returns to surface = 5 Bbl slurry to pit. Job complete. Rig down.
