REMARKS: Safety Meeting. Rig up to 4 1/2 casing. Break circulation pump 5 bbls ahead. Pump 400' G-1 Flush w/ Halls & 5 bbls water spacer. Mix 135 sks Thick set cement w/ 5" Kel-Sool & 1" phen seal pilluk AT 125' per 100'. Washout pump & lines. Shut down. Release plug. Displace with 20 bbls fresh water. Final Dumping Pressure 700'. Pump plug to 1200'. Wait 2 min. Release pressure. Plug held. Good cement returns to surface 10 bbl slurry to pit. Job complete. Rig down.
