To Whom It May Concern:

In regard to the water well located in the NE/4 NE/4 SE/4 of Section 2-15S-20E, completed August 18, 1981, Altavista Energy has determined that it is not in the stated location and is no longer in use.

In the last 90 days, Altavista Energy has intented 7 wells, thus far, that are theoretically within 660 feet of the water well in question. For the first well, we sent a letter to the landowner and did not receive a response. For the ensuing wells, we felt it would be best to talk with the landowner, Frank Turley, regarding the well, to be sure it wasn't an issue for him. Mr. Turley stated that the well was in fact on his property, and that he had plugged it many years ago and built a garage over where it used to be. He also stated that he had no concerns with our drilling activity, and gets all of his water from a rural water meter now.

Additionally, based on our mapping the well was originally located at approximately Lat. 38.77390, Lon. -95.15285 based on the NAD83 coordinate system. This would put the well more than 660 feet from any additional wells we are drilling, including those on the Baldwin Unit lease.
