Pumped 2 Bbls Dye water Ahead, Mixed 152 sacks 70/30 Pozmix cement w/chemicals. Shut down - wash out Pump Lines - Release 2 Top Rubber Plugs - Disposal Plugs with 6 1/2 Bbls water. Final Pumping @ 500 PSI - Pumped Plugs to 1000 PSI - close Tubing w/ 1000 PSI. Good cement returns to surface with 4 Bbl slurry
