Shut down wash out pump & lines. Stuff two plugs & displace with 4.9 Bbl water. Final pumping pressure of 300 psi, bumped plug to 800 psi. Wait two minutes check float & plugs, held good release pressure to 0 psi & shut in. Good circulation @ all times, 3 Bbl slurry to pit Job complete.
