Lowell Foos with Lowell Foos Oilfield Tractor Works, Bazine, Kansas, will be build the lease road and well site location.

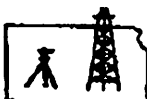

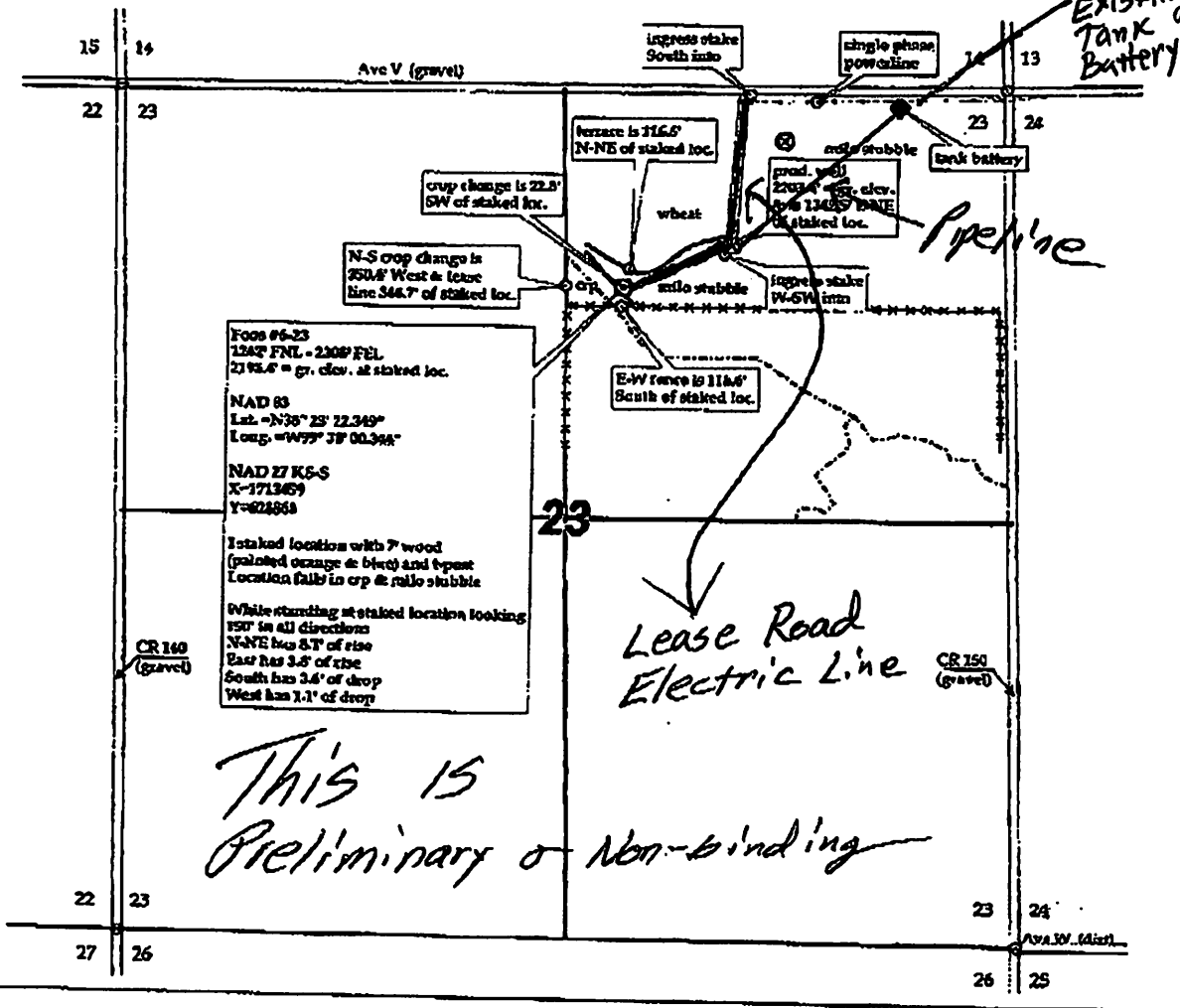
