AFFIDAVIT

The undersigned hereby affirms that the drilling, completion and eventual plugging of this well will comply with K.S.A. 55 et. seq.

It is agreed that the following minimum requirements will be met:

1. Notify the appropriate district office **prior** to spudding of well;
2. A copy of the approved notice of intent to drill **shall be** posted on each drilling rig;
3. The minimum amount of surface pipe as specified below **shall be set** by circulating cement to the top; in all cases surface pipe **shall be set** through all unconsolidated materials plus a minimum of 20 feet into the underlying formation.
4. If the well is dry hole, an agreement between the operator and the district office on plug length and placement is necessary **prior to plugging**;
5. The appropriate district office will be notified before well is either plugged or production casing is cemented in;
6. If an ALTERNATE II COMPLETION, production pipe shall be cemented from below any usable water to surface within **120 DAYS** of spud date. Or pursuant to Appendix "B" - Eastern Kansas surface casing order #133,891-C, which applies to the KCC District 3 area, alternate II cementing must be completed within 30 days of the spud date or the well shall be plugged. **In all cases, NOTIFY district office** prior to any cementing.

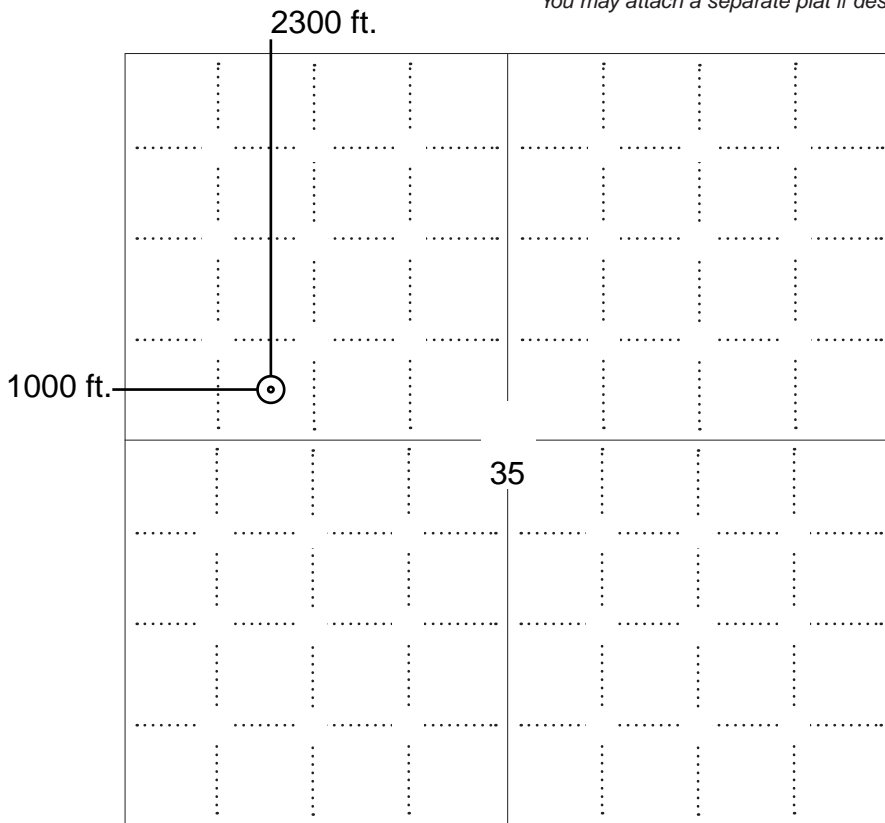

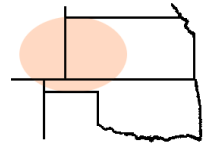

Directions: From the North side of Pence Ks at the intersection of Rd 270 & Cherokee Rd – Now go 4 miles East on Rd 270 – Now go 2 miles North on Grant Rd – Now go 1.5 mile East on Rd 290 to ingress stake North into – Now go 0.5 North on trail to ingress stake East into – Now go 1 mile East on trail – Now go approx. 2640' North through unknown crop – Now go approx. 500' West through wheat & milo stubble to locked gate & ingress stake West into – Now go approx. 2460' West through pasture to ingress stake North into – Now go approx. 3070' North through pasture into staked location.
