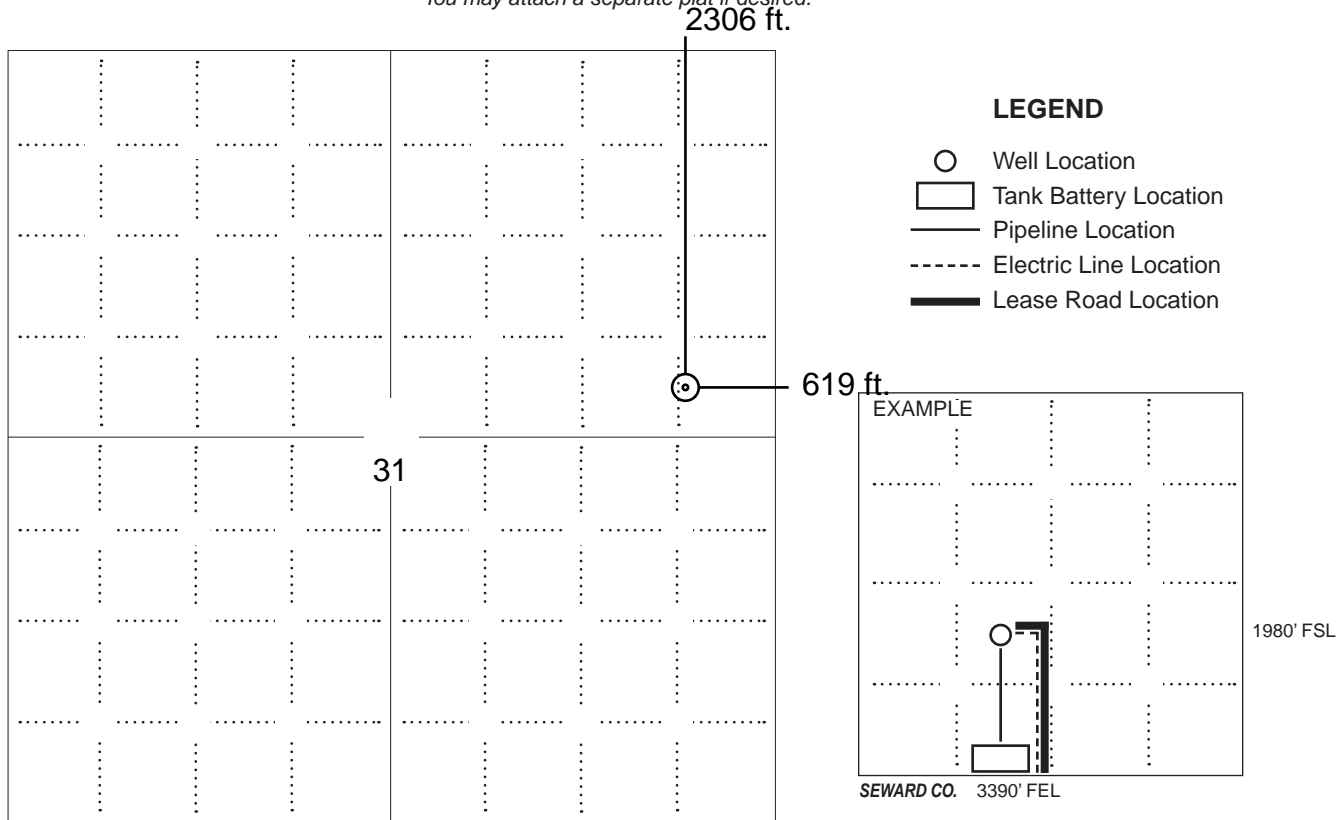

5. The predicted locations of lease roads, tank batteries, pipelines, and electrical lines.

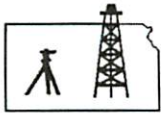

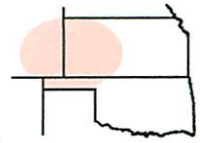

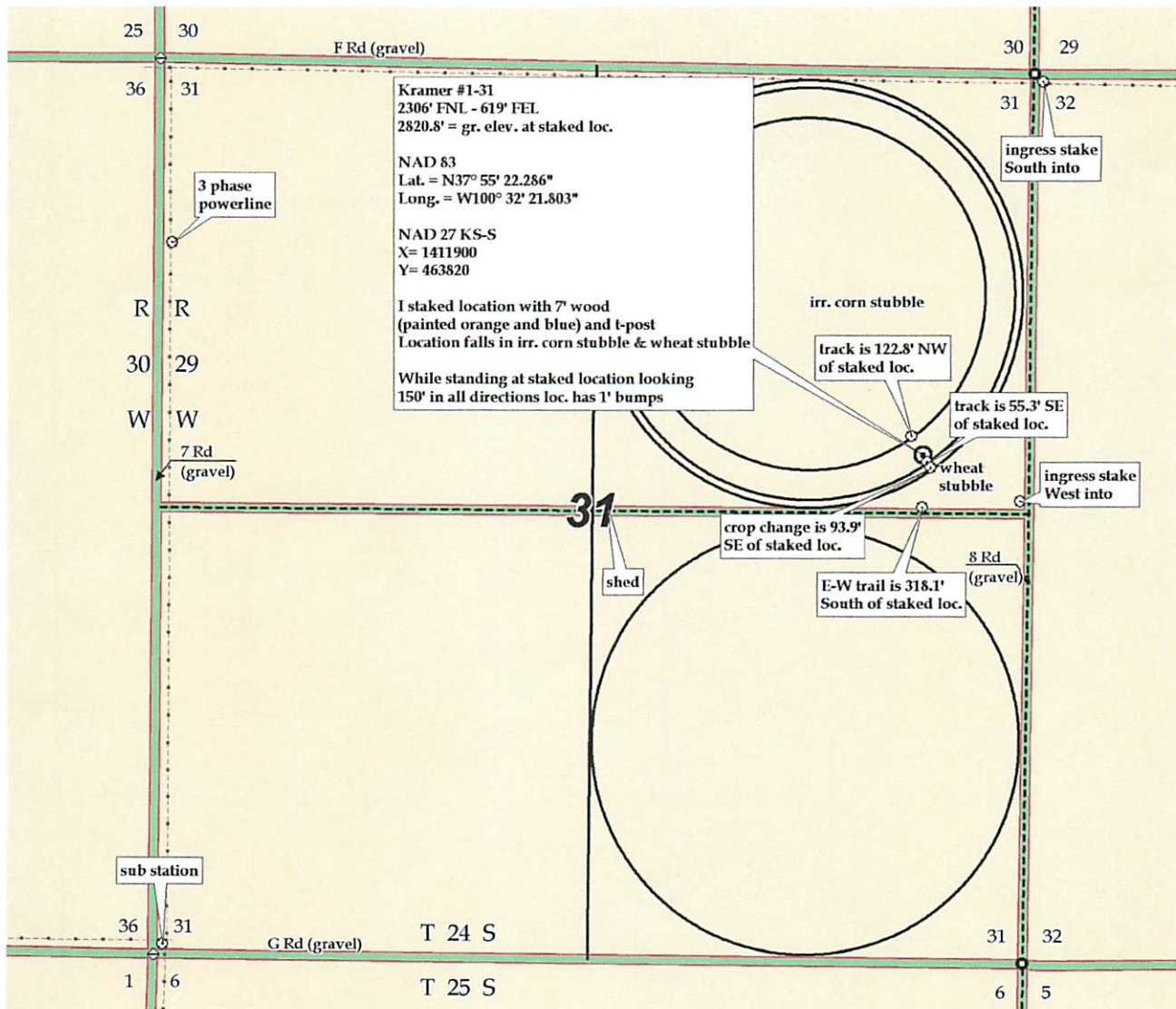

If you want to be involved with the locations, contact Mr. Lowell Foos (785) 731-5612, reference the captioned well name and coordinate with him.

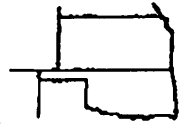
