COMANCHE COUNTY, KANSAS*



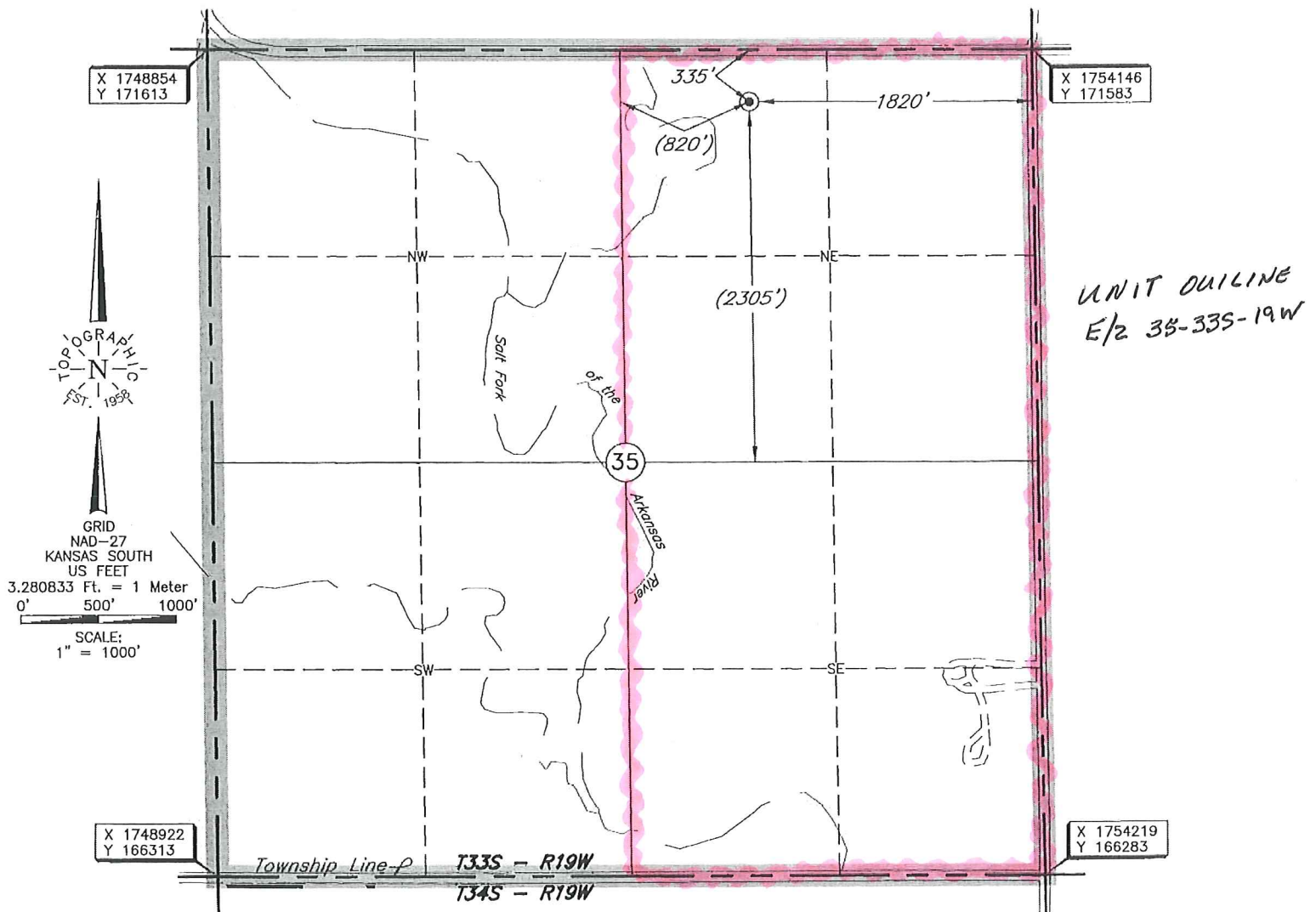

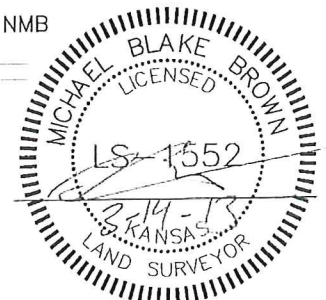
