Your application for Temporary Abandonment (TA) of the above-listed well is denied for the following reasons(s):

**OVR10 - Shut in over 10 years**

In accordance with K.A.R. 82-3-111, this well must be plugged or returned to service by May 11, 2013.

You may file an application for an exception to the 10-year limitation in K.A.R. 82-3-111 to demonstrate why it is necessary to TA the above well for more than (10) years. You must notify the Commission in writing no later than May 11, 2013 of your intention to file the application, and your complete application is due June 10, 2013. All applications and written notifications must be sent to the attention of the Executive Director at the Kansas Corporation Commission Conservation Division at 130 South Market, Room 2078, Wichita, Kansas 67202.
