### **Procedure**

- 1. Notify KCC District 1 at least 5 days before plugging operations. KCC District 1: (620) 225-8888.
- 2. MIRU WOR. PU 5 ½" CIBP, TIH with plug and set at ±4300'. Dump 2 sx cement w/2% CaCl<sub>2</sub> on top of CIBP (Plug 1). TOOH w/tubing while circulating plugging mud.
- 3. RU to pull 5 ½" casing and weld on pull nipple. PU on casing, MIRU WLU and RIH w/tools and locate freepoint. RIH w/cutting tools and cut casing above freepoint (estimated ~3500'). POOH with WL tools and TOOH with 5½" casing laying down.
- 4. TIH with tubing, pump the following plugs in casing/open hole displacing with plugging mud:

 Plug 2: Stub plug (3600'-3400')
  $60 \text{ sx w/ } 2\% \text{ CaCl}_2$  

 Plug 3: Shoe plug (500'-300')
  $70 \text{ sx w/ } 2\% \text{ CaCl}_2$  

 Plug 4: Surface plug (34'-4')
  $10 \text{ sx. w/ } 2\% \text{ CaCl}_2$ 

5. Cut off casing 4ft. below ground level, weld on steel ID plate. RDMO WOR.

#### Dear Dawn Richardson:

This letter is to notify you that the Conservation Division has received your plugging proposal, form CP-1, for the above well and has reviewed the proposal for completeness. The central office will now forward your CP-1 to the district office listed below for review of the proposed plugging method. Please contact the district office for approval of your proposed plugging method at least five (5) days before plugging the well, pursuant to K.A.R. 82-3-113(b). If a workover pit will be used during the plugging of the well it must be permitted. A CDP-1 form must be filed and approved prior to the use of the pit in accordance with K.A.R. 82-3-600.

The Conservation Division's review of form CP-1, either in the central or district office, does not include an inquiry into well ownership or the filing operator's legal right to plug the well. This notice in no way constitutes authorization to plug the above well by persons not having legal rights of ownership or interest in the well.

This notice is void after October 28, 2013. The CP-1 filing does not bring the above well into compliance with K.A.R 82-3-111 with regard to the Commission's temporary abandonment requirements.
