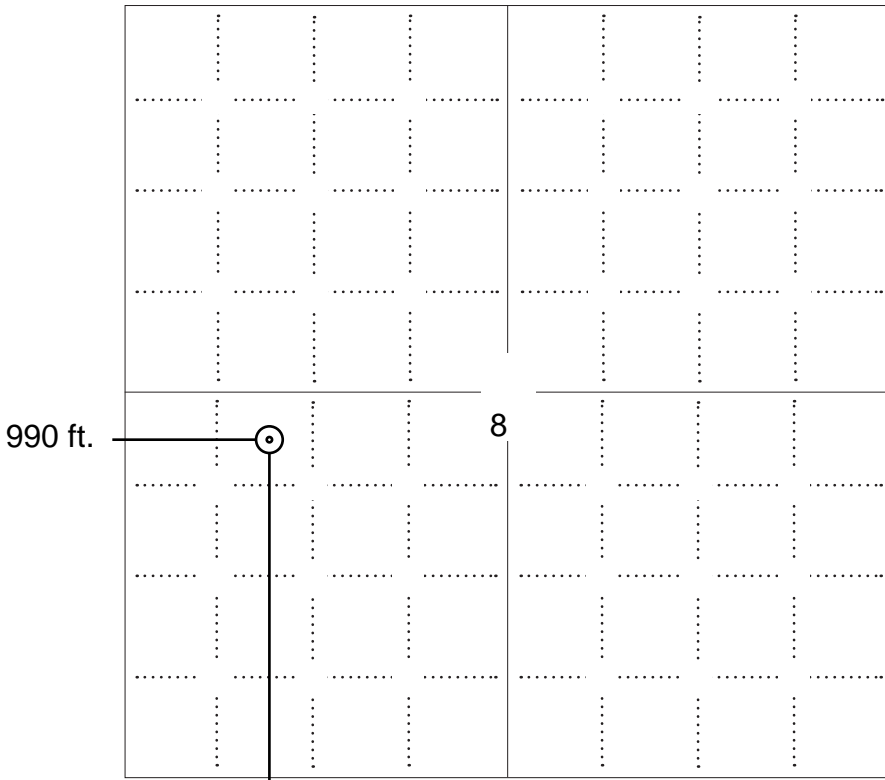

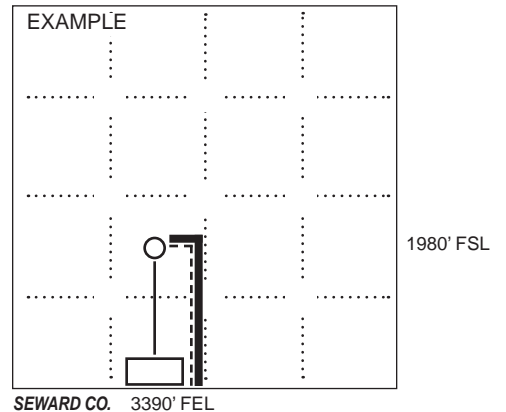

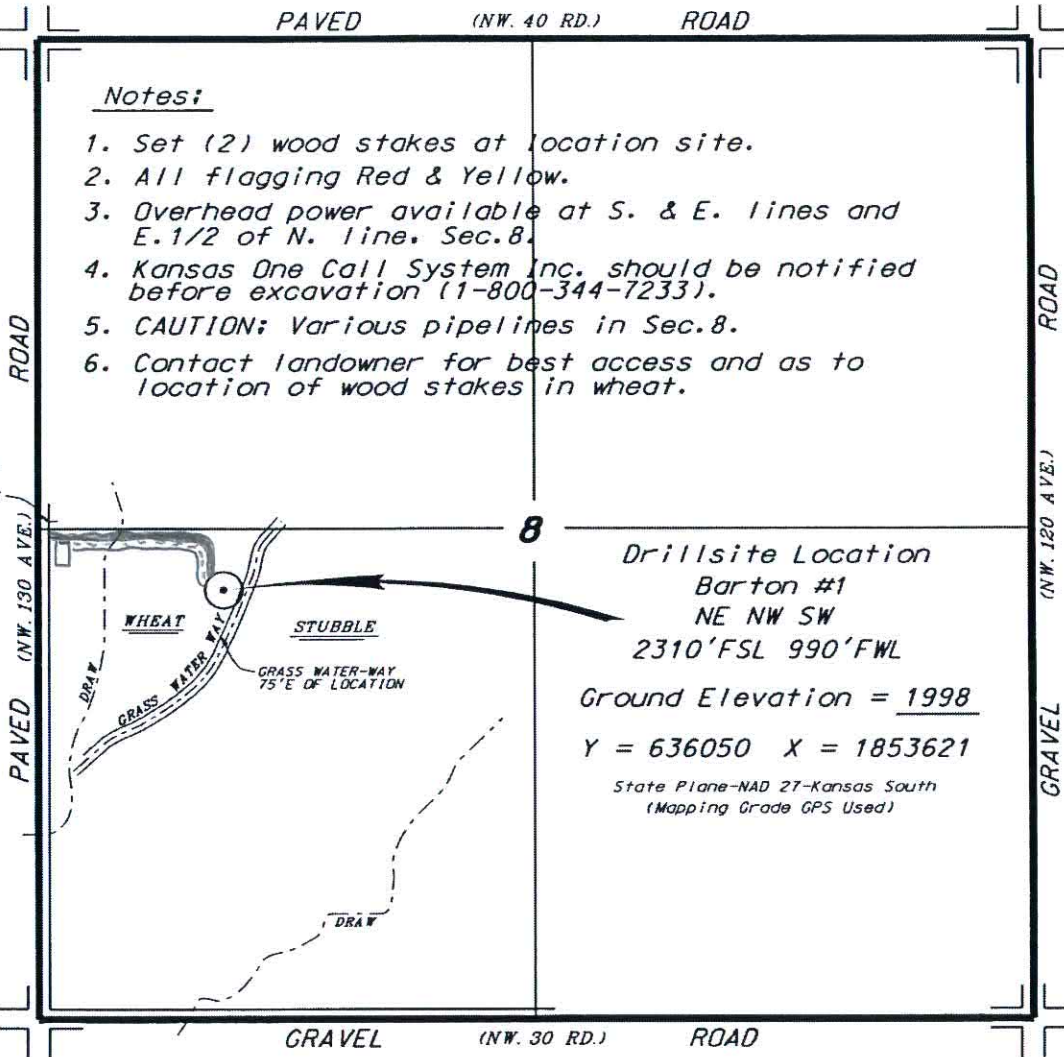

FLAGGED FIELD ENTRANCE



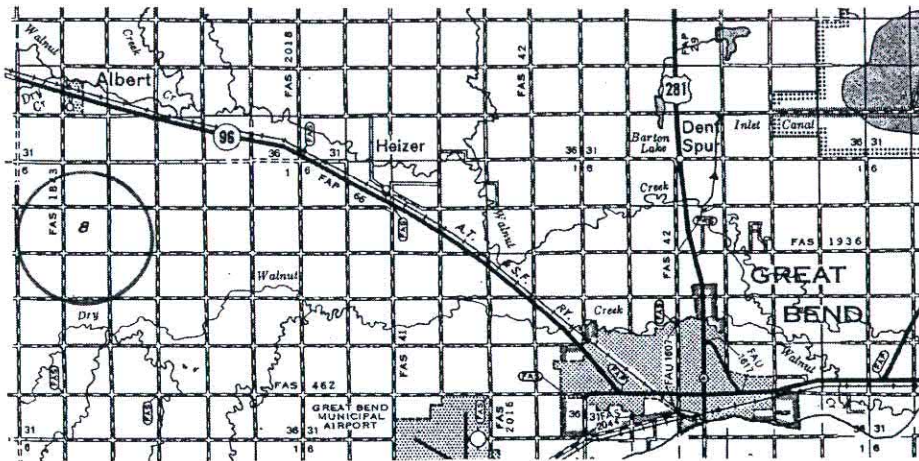
