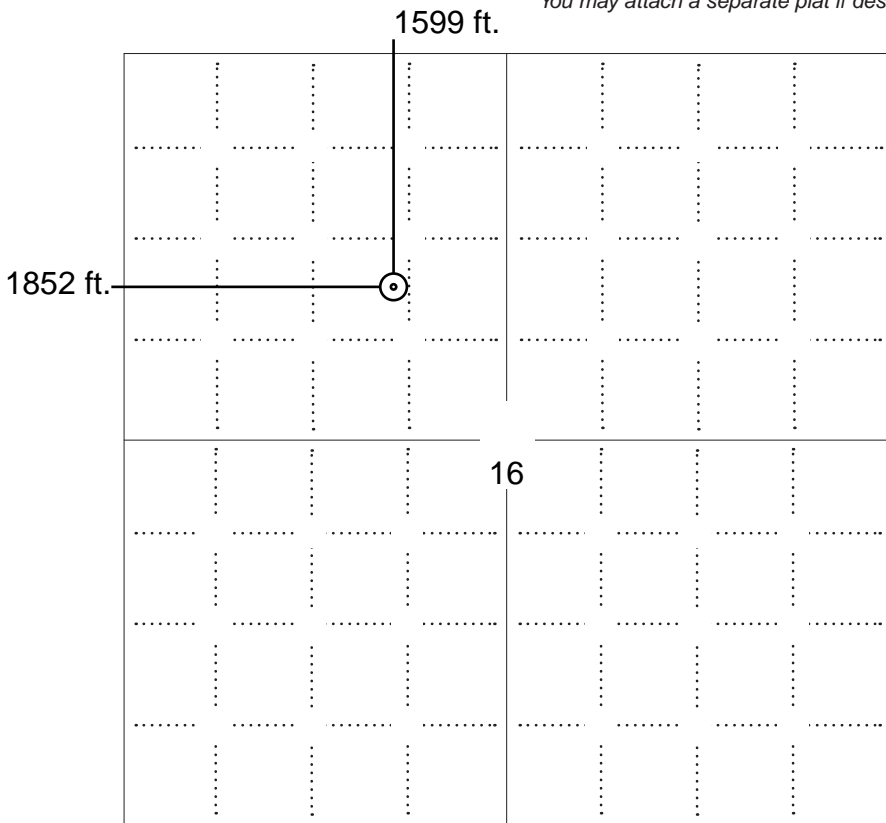

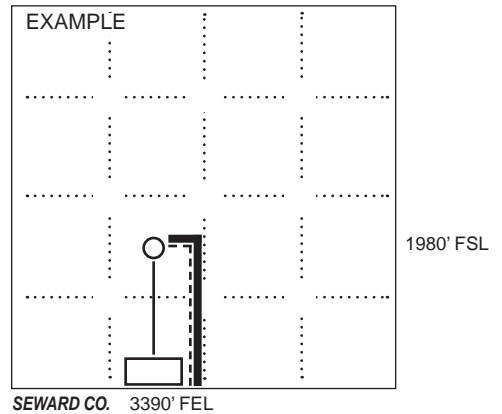

4. If proposed location is located within a prorated or spaced field a certificate of acreage attribution plat must be attached: (C0-7 for oil wells; CG-8 for gas wells).
5. The predicted locations of lease roads, tank batteries, pipelines, and electrical lines.

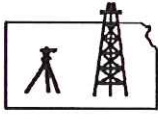

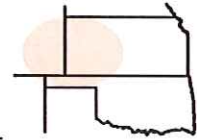

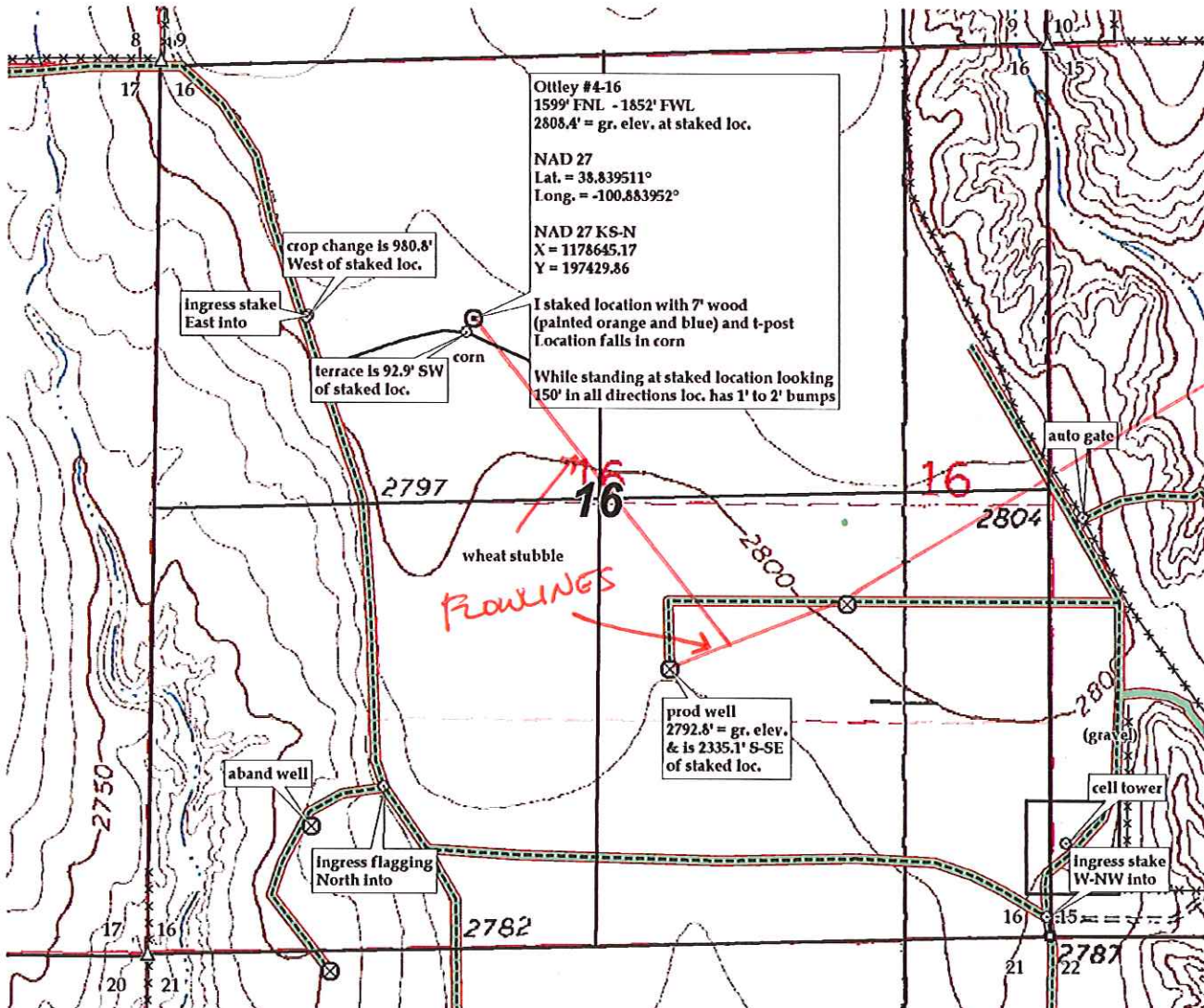

Directions: From the South side of Oakley, Ks at the intersection of Hwy 40 & Hwy 83 South – Now go 20 miles South on Hwy 83 – Now go 1 mile West and NW on Jayhawk Rd to ingress S-SW into – Now go 0.4 mile S-SW on trail to ingress stake W-NW into – Now go 0.8 mile W-NW on trail to ingress flagging North into – Now go 0.5 mile North on trail to ingress stake East into – Now go approx. 980' East through corn into staked location.

Final ingress must be verified with land owner Operator.
