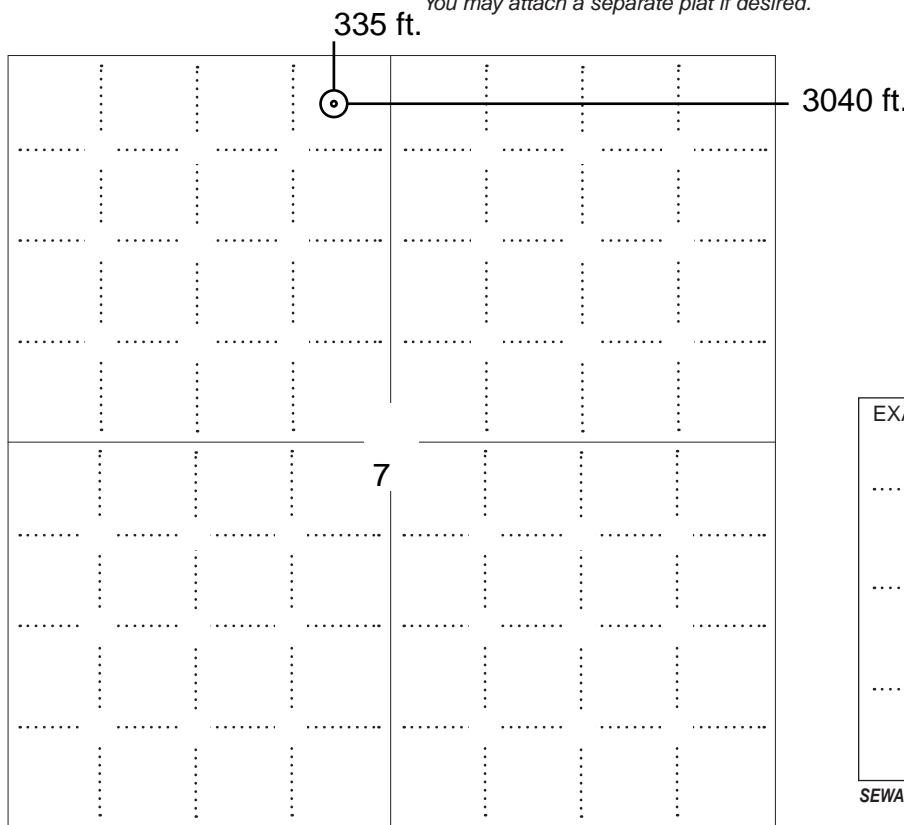

5. The predicted locations of lease roads, tank batteries, pipelines, and electrical lines.

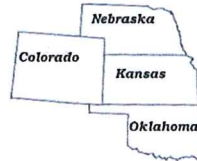

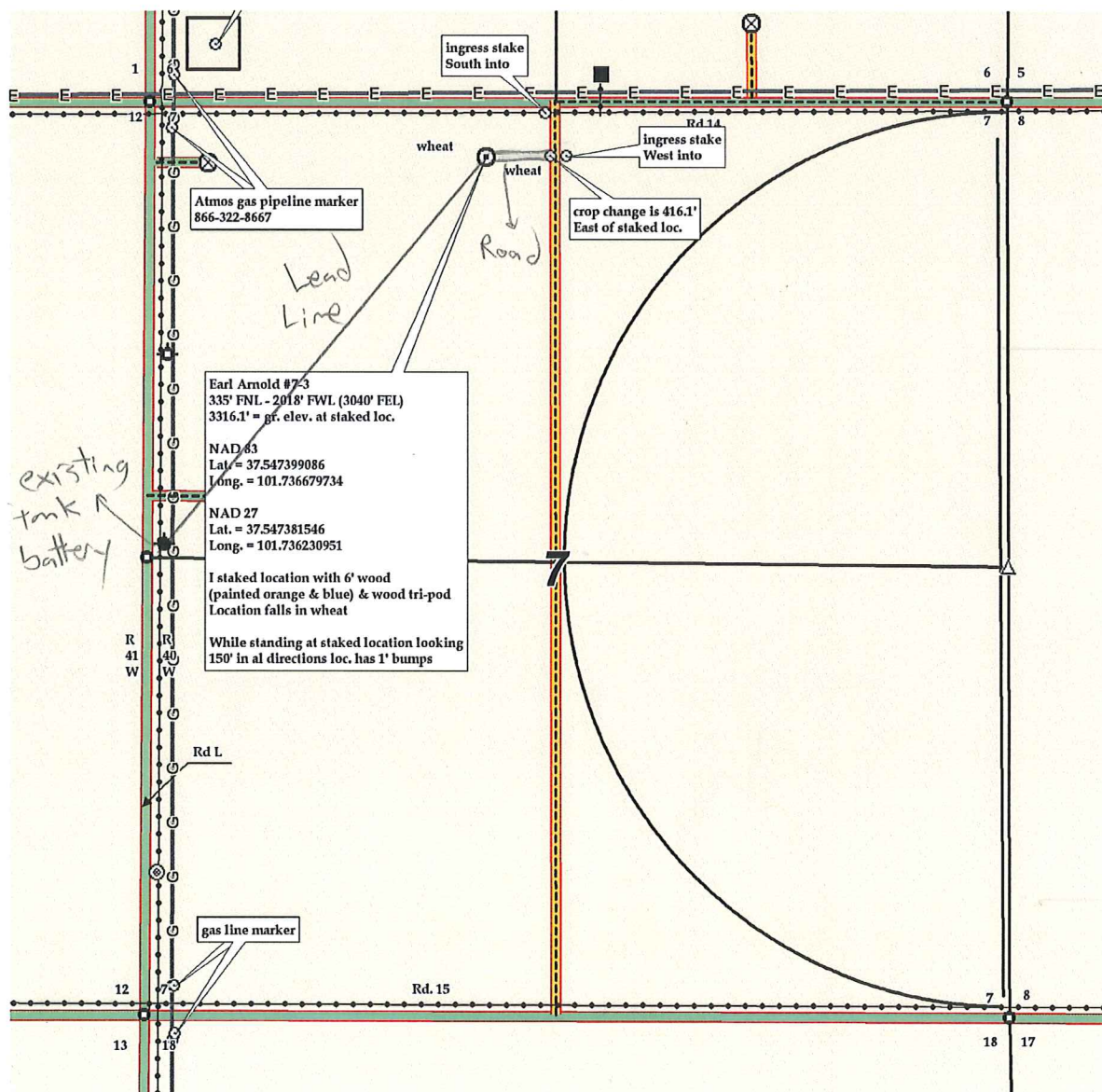

DIRECTIONS: From the SW side of Johnson City, KS at the intersection of Hwy 160 West & Hwy 27 – Now go 1 mile South on Hwy 27 – Now go 1 mile East on Rd. 14 to the NW corner of section 7-29s-40w – Now go 0.5 mile East on Rd. 14 to ingress stake South into – Now go 0.1 mile South on trail to ingress stake West into – Now go 416' West through wheat, into staked location.

Final ingress must be verified with landowner or operator.
