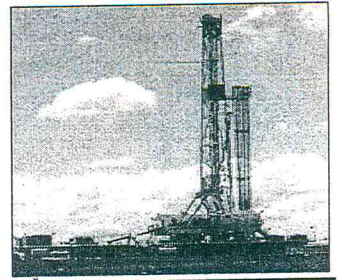

K.A.R. 82-3-107 provides for all completion information to be filed within 120 days of the spud date. Subsection(e)(2) of that regulation states "All rights to confidentiality shall be lost if the filings are not timely."

The above referenced well was spudded on 5/14/2013 and the ACO-1 was received on September 12, 2013 (not within the 120 days timely requirement).
