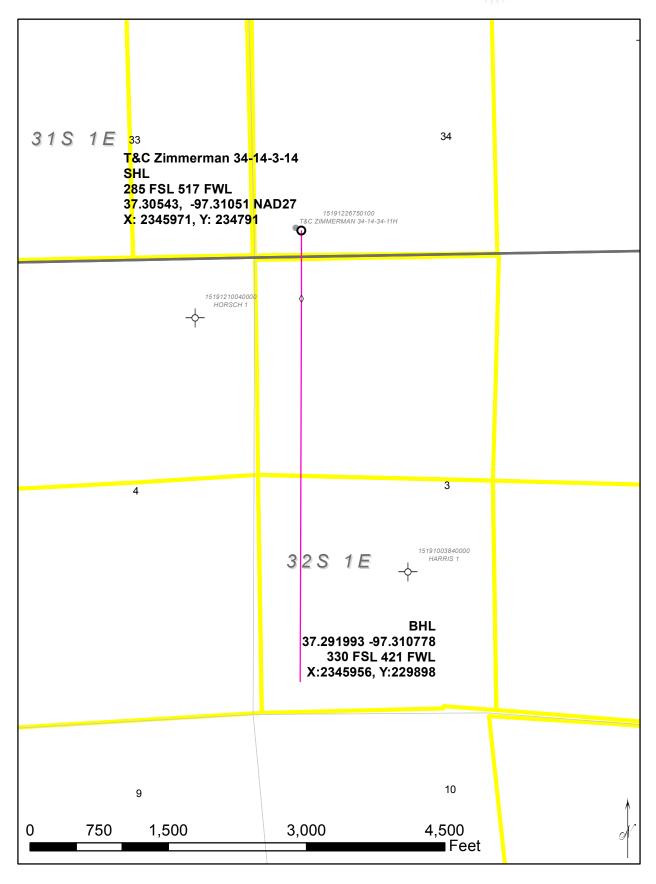

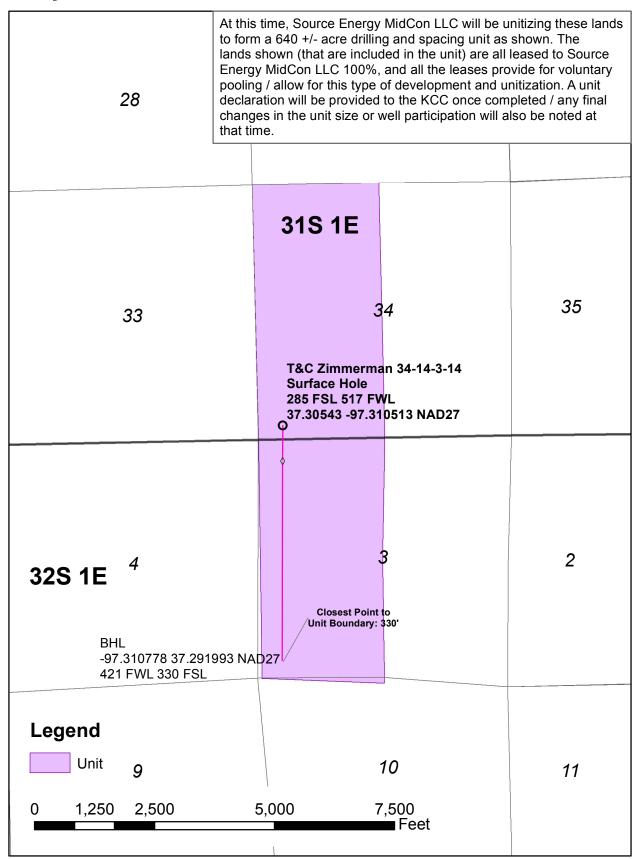

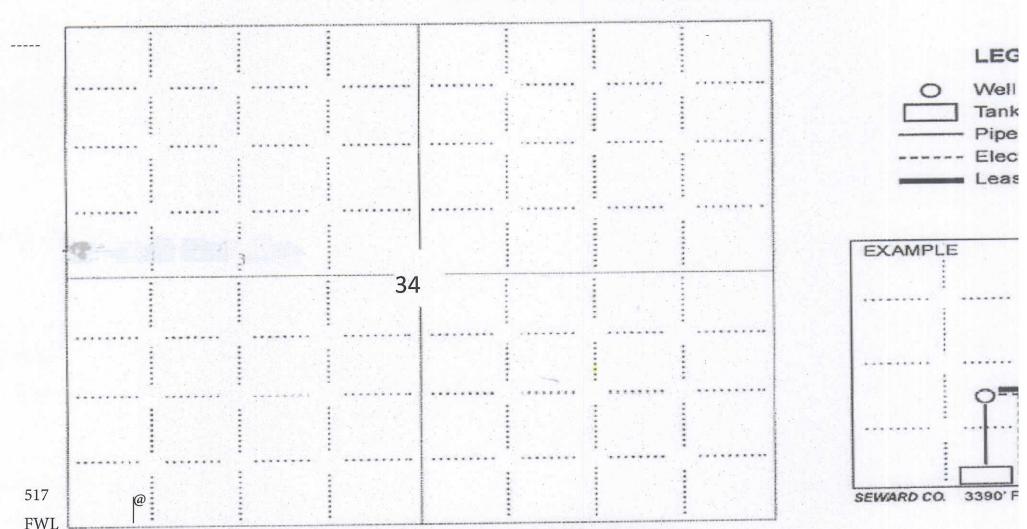


Proposed Source 640 +/- acre unit
