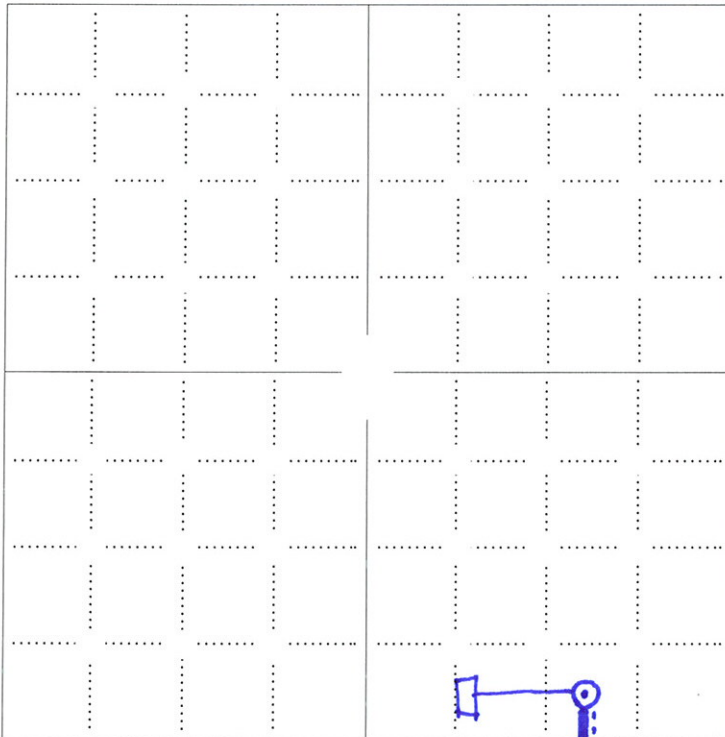

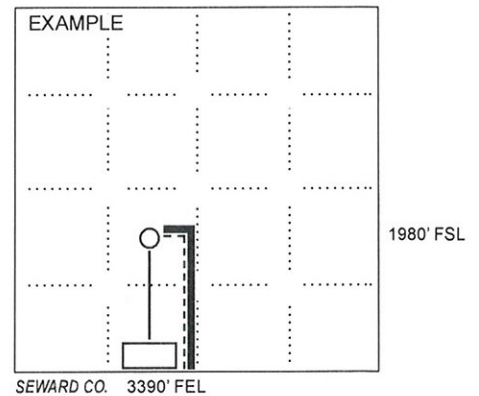

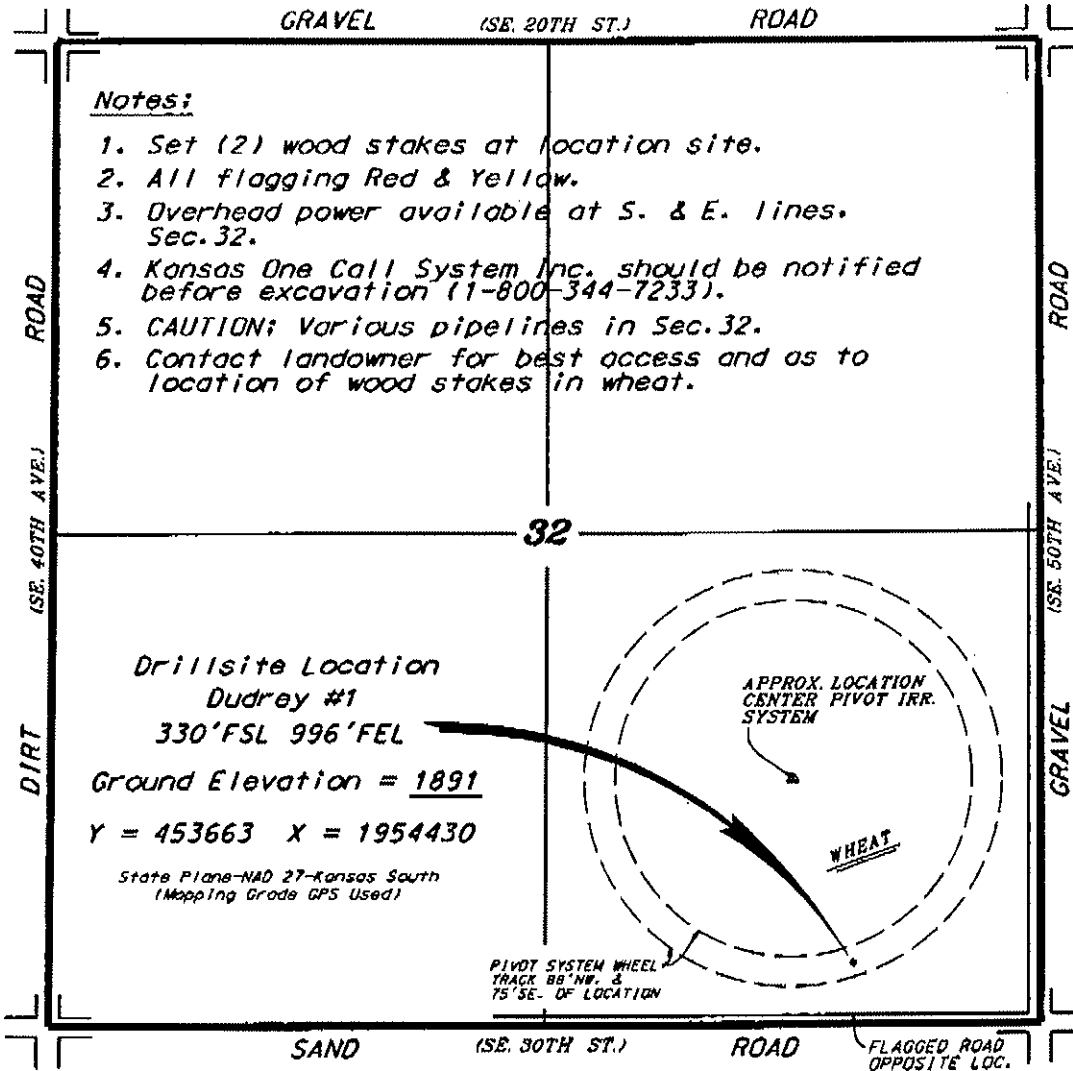


NOTE: In all cases locate the spot of the proposed drilling location.

5. The predicted locations of lease roads, tank batteries, pipelines, and electrical lines.

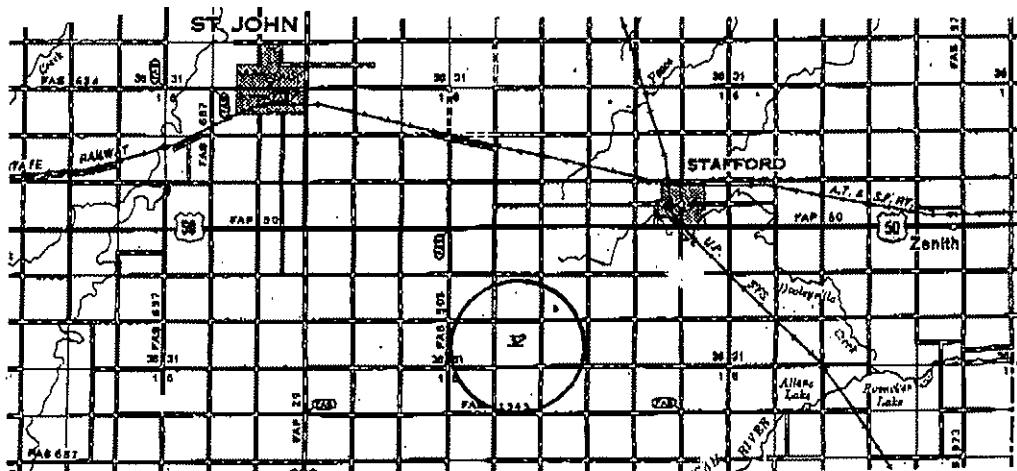
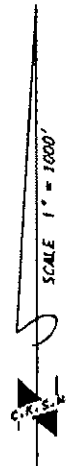
