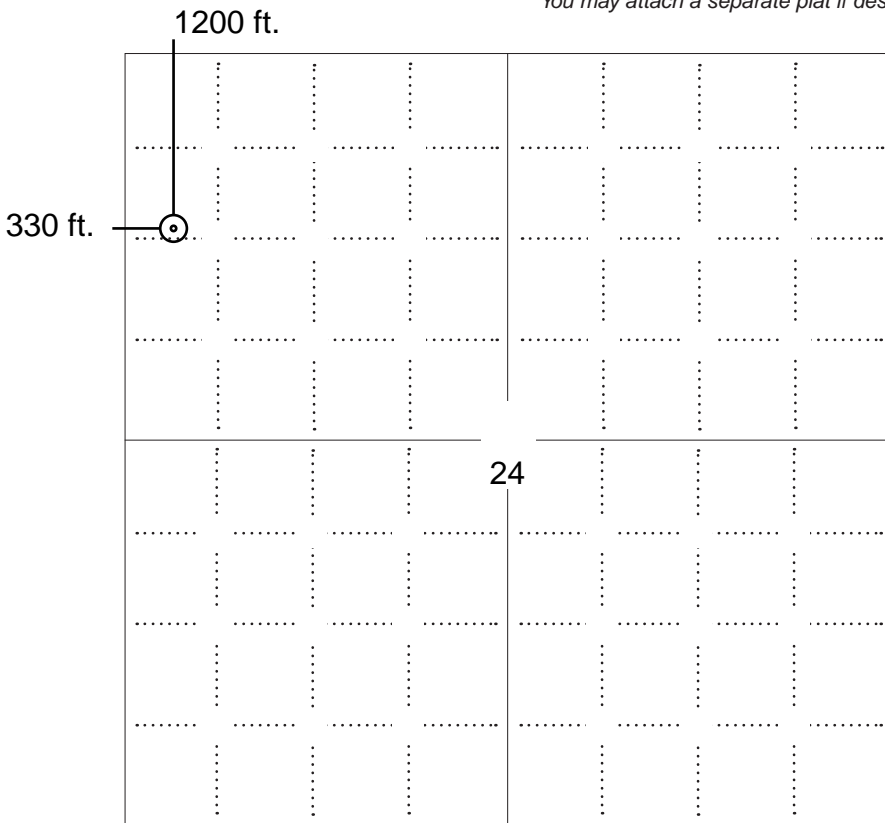

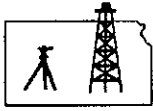

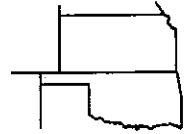

**Directions:** From approx. 1/2 mile NE of Beeler, Ks at the junction of Hwy 96 & Rd C/Road 523 South - Now go 5 miles South on Rd C/Road 523 - Now go 1.5 mile East on 80 Rd - Now go 0.5 mile North on unknown rd - Now go 0.5 mile East, which is approx. 0.5 mile South of the NW corner of section 24-19s-26w - Now go 0.5 mile East on unknown rd - Now go 0.3 mile North on unknown rd to ingress stake West into - Now go 0.4 mile West on lease rd to ingress stake South into - Now go approx. 865' South through milo stubble into staked location.
