1. MIRU PU.
2. NU BOP.
3. MI +150 JTs Work String TBG.
4. TIH w/ Bit & Scraper and clean/scrap to **PBTD 4,552'**
5. TOOH w/ Bit & scraper
6. MIRU WL Run CBL to determine TOC (**To 1,500' min.**)
  - a. send copy of CBL to engineer
7. TIH w/ **1' 4 SPF 90° Phasing Angle gun**, Perf **Permian** (~1000')
  - a. If TOC is Above Permian and we have good cement from old squeeze to TOC, Perf above TOC.
8. PU RIH w/ WS to PBTD 4,552'
9. **[PLUG 1] Mix 55 sx 60/40 4% Gel cmt w/ 300lbs Hull mixed**, spot from PBTD to 4,000' (**100' over Top Perfs**), Tag TOC to confirm cement.
10. PU to Perfs, squeeze **150 sx 60/40 4% Gel** cmt behind Pipe

- a. If not able to pump **150 sx through perfs**, pump 150sx **down backside** from top.
11. **[PLUG 2]** Spot plug from perfs to surface **PLUS 80 Sx Over Casing Volume**
12. TOOH, RDMO cmt trucks.
13. SI well and WOC to Cure.
14. ND cementing valves and cut off wellhead. Fill 5.5" casing with cement as necessary. Install P&A marker to comply with regulations. RDMO and restore location.

Dear Tami Troxel:

This letter is to notify you that the Conservation Division has received your plugging proposal, form CP-1, for the above well and has reviewed the proposal for completeness. The central office will now forward your CP-1 to the district office listed below for review of the proposed plugging method. **Please contact the district office for approval of your proposed plugging method at least five (5) days before plugging the well, pursuant to K.A.R. 82-3-113(b). If a workover pit will be used during the plugging of the well it must be permitted. A CDP-1 form must be filed and approved prior to the use of the pit in accordance with K.A.R. 82-3-600.**

The Conservation Division's review of form CP-1, either in the central or district office, does not include an inquiry into well ownership or the filing operator's legal right to plug the well. This notice in no way constitutes authorization to plug the above well by persons not having legal rights of ownership or interest in the well.

**This notice is void after July 28, 2014. The CP-1 filing does not bring the above well into compliance with K.A.R 82-3-111 with regard to the Commission's temporary abandonment requirements.**
