Mixed 120 sks 60/40 Pozmix Cement w/ 4% Gel, 2% Cacl2, + 1# Phenoseal/sk @ 14#/gal. Shut down, washout pump + lines. Displace w/ 13.8 Bbl Fresh water. Final pumping pressure of 300 PSI. Shut well in w/ 250 PSI on it. Good circulation @ all times. 4 Bbls Cement Slurry to pit. Job Complete. Rig down. T.O.C. 870' +/-

(Note: Could not pump into. Pressured to 3500 PSI. Raised casing w/ Rig. & got circulation & washed down.)

(Note: Displaced w/ water. No plug.)
