Mix 100# Caustic Soda Pre-Flush w/ 10 Bbl water. 10 Bbl water spacer. Mixed 150 sks Thickset Cement w/ 5" Kal-seal/sk, + Phenoseal @ 1/4" /sk @ 13.8 g/gal. Shut down. Unhook pump & lines. Release Plug. Displace w/ 21 Bbl Fresh water. Final pumping pressure of 1250 PSI. Bump Plug to 1800 PSI. Released pressure. Plug Held. Good circulation @ all times. 6 Bbl cement slurry to pit. Job complete. Rig down.
