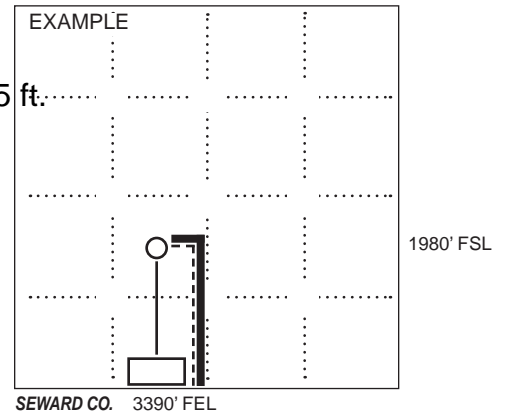

**Directions:** From the North side of Pierceville, Ks at the intersection of Hwy 50 & Main St. South - Now go 16.4 mile SW & South on Main St. / Pierceville Rd. - Now go 2 miles East on 70 Rd. & 2 miles East on Y RD to the SE corner of section 32-27s-30w and ingress stake North into - Now go 0.5 mile North on trail - Now go 0.1 mile on trail to ingress stake South into - Now go 382' South through dry land corn, into staked location.
