Mixed 156 sks. 70/30 Pozmix cement w/ 2% Gel & Flocide. Shut down - washout pump skins, Release 2- Top Rubber Plugs, Displaced Plugs with 6 Bbls water. Final Pumping at 500 PSI, Bumped Plugs to 1000 PSI, closed Tubing w/ 1000 PSI. Good cement returns with 5 Bbl. slurry
