

# (3) dispose of the remaining solid contents in any manner required by the commission. The requirements may include any of the following:

- (A) Burial in place, in accordance with the grading and restoration requirements in K.A.R. 82-3-602 (f);
- (B) removal and placement of the contents in an on-site disposal area approved by the commission;
- (C) removal and placement of the contents in an off-site disposal area
