District staff has inspected the location and has determined that an unsealed condition will present a pollution threat to water resources.

District staff has instructed that no earthen pits are to be used at this location. Steel pits are to be used. Please file form CDP-5, Exploration and Production Waste Transfer, within 30 days of fluid removal.
