DECLARATION OF POOLING AND CONSOLIDATION

THIS DECLARATION OF POOLING AND CONSOLIDATION is made and entered into this 1st day of October 2014, by John Jay Darrah, Jr., as Lessee.

KNOW ALL MEN BY THESE PRESENTS: That

WHEREAS, the following described oil and gas leases are owned by Darrah Oil Company, LLC, as Lessee, to wit:

Oil and Gas Lease dated August 6, 2012, by and between Terry L. Gaunt and Glenda Gaunt, husband and wife, as Lessor, and John Jay Darrah, Jr., as Lessee, covering the lands situated in the South Half of the Northwest Quarter (S/2 NW/4) of Section 31, Township 20 South, Range 13 West, as recorded in the office of the Register of Deeds of Barton County Kansas, in Book 617 at Page 2305 containing 80 acres more or less.

Oil and Gas Lease dated August 24, 2012, by and between Bernice K. Henkle Living Trust, Susan M. Muth, Trustee, as Lessor, and John Jay Darrah, Jr., as Lessee, covering the lands situated in the South Half of the Northeast Quarter (S/2 NE/4) of Section 31, Township 20 South, Range 13 West, as recorded in the office of the Register of Deeds of Barton County Kansas, in Book 617 at Page 2837, containing 80 acres more or less.

WHEREAS, said Oil and Gas Leases provide inter alia as follows:

"Lessee, at its option, is hereby given the right and power to pool or combine the acreage covered by this lease or any portion thereof with other land, lease or leases in the immediate vicinity thereof, when in lessee's judgment it is necessary or advisable to do so in order to properly develop and operate said lease premises so as to promote the conservation of oil, gas or other minerals in and under and that may be produced from said premises, such pooling to be of tracts contiguous to one another and to be into a unit or units not exceeding 40 acres each in the event of an oil well, or into a unit or units not exceeding 640 acres each in the event of a gas well. In lieu of the royalties elsewhere herein specified, lessor shall receive on production from a unit so pooled only such portion of the royalty stipulated herein as the amount of his acreage placed in the unit or his royalty interest therein on an acreage basis bears to the total acreage so pooled in the particular unit involved", and

WHEREAS, John Jay Darrah Jr., as the owner and lessee of the above described oil and gas leases, has determined in its judgement that it is necessary and advisable to pool and combine the oil rights in and under a portion of the acreage and lands covered by the above described oil and gas leases in order to properly develop said lease premises so as to promote the conservation of oil, gas or other minerals in and under and that may be produced from said premises as one oil operating unit, upon the terms and conditions hereinafter provided and as provided in said oil and gas leases;

Northeast Quarter of the Southeast Quarter of the Northwest Quarter (NE/4 SE/4 NW/4), and the Northwest Quarter of the Southwest Quarter of the Northeast Quarter (NW/4 SW/4 NE/4), and the Southeast Quarter of the Southeast Quarter of the Northwest Quarter (SE/4 SE/4 NW/4), and the Southwest Quarter of the Southwest Quarter of the Northeast Quarter (SW/4 SW/4 NE/4), in Section 31, Township 20 South, Range 13 West, Barton County, Kansas, containing 40 acres more or less;

To the same extent as if said oil leasehold estate had originally been included in one oil and gas lease, which pooled and combined area is hereby designated as the Gaunt Unit #1-31, and which area shall include within the same all land covered by the above described oil and gas leases insofar and only insofar as the same are included within the above described oil unit.



Dear Will Darrah:

District staff has inspected the above referenced location and has determined that the reserve pit shall be constructed <u>without slots</u>, the bottom shall be flat and reasonably level and the free fluids must be removed. The fluids are to be removed from the reserve pit as soon as the Hutchinson Salt section has been drilled through and displacement of the fluids into the reserve pit has occurred. The fluids should be removed again within 72 hours after drilling operations have ceased.

If production casing is set all completion fluids shall be removed from the working pits daily. NO completion fluids or non-exempt wastes shall be placed in the reserve pit.

The fluids should be taken to an authorized disposal well. Please call the District Office at (785) 625-0550 when the fluids have been removed. Please file form CDP-5 (August 2008), Exploration and Production Waste Transfer, through KOLAR within 30 days of fluid removal.
