Recommendation

The referenced well is recommended for plugging and abandonment.

Discussion

The Foster 2-18 was drilled and completed in July 1965 to a total depth of 6,900'. Initially, the Morrow was acidized & frac'd w/ 80Q foamed acid w/ 7 ½% HCL & 155,000 scf N2. Treat Morrow w/ 50 bbl 3% acid, 22,700 gal gel 3% acid w/ 500# hulls, 18M# 20/40 sand Acidize w/ 1M gal 7 ½% HCL w/ double strength FE,. Chesapeake acquired the well from Hugoton in 1998. .

The well has produced a cumulative 219.1 MMCF and has 245 MMCF remaining reserves (2Q14). Geology has determined no uphole potential and the well has been temporarily abandoned. The lease has expired and Chesapeake has plugging liability.

The gross estimate AFE cost to P&A the well is \$26.3M (\$26.3M net to COI). Partner approval will not be necessary to commence operations.

Procedure

1. Notify KCC District 1 at least 5 days before plugging operations
KCC District 1: (620)225-8888
2. MIRU WOR, ND WH, NU BOP, TOO H with tubing
3. RU to pull 4 ½" casing and weld on pull nipple. PU on casing, MIRU WLU and RIH w/tools and locate freepoint. RIH w/cutting tools and cut casing above freepoint (estimated ~2285'). POOH with WL tools and TOO H with 4 ½" casing laying down.
4. TIH with tubing, pump the following plugs in casing/open hole displacing with plugging mud:

Plug 1: Shoe & FW Plug (2235-2135')	70 sx. w/ 2% CaCl ₂
Plug 2: BTW plug (est 500-600')	50 sx. w/ 2% CaCl ₂
Plug 3: Surface plug (34'-4')	10 sx. w/ 2% CaCl ₂
5. Cut off casing 4ft. below ground level, weld on steel ID plate. RDMO WOR.

The Conservation Division has received your Well Plugging Application (CP-1).

Under K.A.R. 82-3-113(b)(2), you must notify DISTRICT 1 of your proposed plugging plan at least 5 days before plugging the well. DISTRICT 1's phone number is (620) 225-8888. Failure to notify DISTRICT 1, or failure to file a Well Plugging Record (CP-4) after the well is plugged will result in a penalty recommendation.

Under K.A.R. 82-3-600, you must file an Application for Surface Pit (CDP-1) if you wish to use a workover pit while plugging the well. Failure to timely file a CDP-1, failure to timely remove fluids, or failure to timely file Closure of Surface Pit (CDP-4) or Waste Transfer (CDP-5) forms will result in a penalty recommendation.

This receipt does NOT constitute authorization to plug this well if you do not otherwise have the legal right to do so.

This receipt is VOID after June 12, 2015. If the well is not plugged by then, you will have to submit a new CP-1 if you wish to plug the well.

The June 12, 2015 deadline does NOT override any compliance deadline given to you by Legal, District, or other Commission Staff. Failure to comply with any given deadline will still result in the Commission assessing penalties, or taking other legal action.
