1. MIRUSU spot 2-3/8 work string. Unflange and nipple up BOP.
2. RIH with 7" 10,000 tubing set CIBP and set CIBP @ 2553'. Release from tubing, circulate hole with mud and cap CIBP w/10 sacks Class "C" cement.
3. Pull up hole and spot tubing @ 2200', mix and spot 50 sacks cement to cover Anhydrite. POH w/tubing.
4. RIH with 7" CIBP and set CIBP +/-900'. (Wireline set or tubing set CIBP).
5. RU wireline truck, perf 4 squeeze holes @ 875'.
6. PU 7" packer and TIH, set pkr @ 600', squeeze usable water perfs with 75 sacks cement with 50 lbs. cotton seed hulls in last half of cement. Displace to 700'. WOC. POH with tubing.
7. Perf squeeze holes @ 310'. RIH with packer with 2 joints, breakdown perfs and establish circulation to surface. Mix and pump 130 sacks and circulate to surface, release packer and POH and top off 7" and 7"x10-3/4 annulus.
8. RDMOSU
9. Cut and cap well.

Dear Shawn Hildreth:

The Conservation Division has received your Well Plugging Application (CP-1).

Under K.A.R. 82-3-113(b)(2), you must notify DISTRICT 1 of your proposed plugging plan at least 5 days before plugging the well. DISTRICT 1's phone number is (620) 225-8888. Failure to notify DISTRICT 1, or failure to file a Well Plugging Record (CP-4) after the well is plugged will result in a penalty recommendation.

Under K.A.R. 82-3-600, you must file an Application for Surface Pit (CDP-1) if you wish to use a workover pit while plugging the well. Failure to timely file a CDP-1, failure to timely remove fluids, or failure to timely file Closure of Surface Pit (CDP-4) or Waste Transfer (CDP-5) forms will result in a penalty recommendation.

This receipt does NOT constitute authorization to plug this well if you do not otherwise have the legal right to do so.

This receipt is VOID after November 04, 2015. If the well is not plugged by then, you will have to submit a new CP-1 if you wish to plug the well.

The November 04, 2015 deadline does NOT override any compliance deadline given to you by Legal, District, or other Commission Staff. Failure to comply with any given deadline will still result in the Commission assessing penalties, or taking other legal action.
