In reference to our telephone conversation of this morning and your letter of July 31, 2006, I submit the following information:

Bruce Oil Company removed the tank battery from this lease and will continue to remove the production equipment as needed in the future. For the past two years or more, the tenant and owner of this lease have been using the well for gas to run a center pivot on ~~his~~ <sup>their</sup> ground.

Bruce Oil Company is in negotiations with Dwight Engelland and his son, the owners, to facilitate their taking ownership and operation of the gas flowing from this well. We have informed the Engellands of the necessity of obtaining licensing to formalize their responsibility should they desire to own the well.

If we cannot come to terms with the Engellands, we will abandon and plug the well and remove all equipment and return the ground to normal condition.
