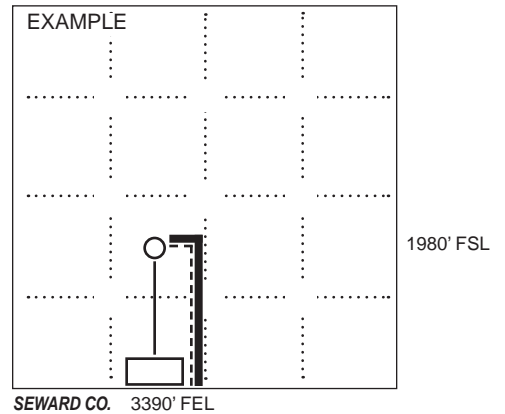

DIRECTIONS: From the center of Scott City, KS at the intersection of Hwy 83 and Hwy 96 - Now go 7 miles North on Hwy 83 to the SE corner of section 12-17s-33w - Now go 0.8 mile North on Hwy 83 to ingress NW and West into - Now go 0.4 mile NW and West on trail to ingress South into - Now go 0.3 mile South and SE on trail to ingress West into - Now go 0.2 mile West and SW to ingress NW into - Now go approx. 430' NW through irr. wheat stubble. - Now go approx. 160' SW through irr. wheat stubble, into staked location.

Final ingress must be verified with landowner or operator.

Dear Ty Lunn:

District staff has inspected the above referenced location and has determined that the reserve pit shall be constructed **without slots**, the bottom shall be flat and reasonably level, and the free fluids must be removed. The fluids are to be removed from the reserve pit within 96 hours of completion of drilling operations.

If production casing is set all completion fluids shall be removed from the working pits daily. NO completion fluids or non-exempt wastes shall be placed in the reserve pit.

The fluids should be taken to an authorized disposal well. Please call the District Office at (620) 225-8888 when the fluids have been removed. Please file form CDP-5 (August 2008), Exploration and Production Waste Transfer, through KOLAR within 30 days of fluid removal.

A copy of this letter should be posted in the doghouse along with the approved Intent to Drill. If you have any questions or concerns please feel free to contact the District Office at (620) 225-8888.
