1. MIRU- Unflange well & NU BOP. Spot workstring.
2. TIH w/tbg & tag fill +/-1900'. Mix & spot 100 sks Class "C" cement w/100# cotton seed hulls with 50 sks. POH & WOC.
3. Tag TOC (1650' or higher) load csg w/mud & test @ 500 psi.
4. RU wireline truck & pull CBL to verify if TOC is above usable water and/or 10 3/4" shoe.
5. (a) If above 10 3/4" shoe @ 495'. Run tbg @ 650' & circ. To surface inside 7" csg w/115 sks Class C cement. POH w/tbg. Fill 7" x 10 3/4" annulus w/ 10-20 sks cmt & pressure to 300 psi.
(b) If TOC below 10 3/4" shoe, perf sq. holes @ 25' above TOC, breakdown perfs & circulate to surface w/350 sks Class "C" cement.
6. RDMOSU- Cut & cap well. Dig up rig anchors.

Dear Shawn Hildreth:

The Conservation Division has received your Well Plugging Application (CP-1).

Under K.A.R. 82-3-113(b)(2), you must notify DISTRICT 1 of your proposed plugging plan at least 5 days before plugging the well. DISTRICT 1's phone number is (620) 225-8888. Failure to notify DISTRICT 1, or failure to file a Well Plugging Record (CP-4) after the well is plugged will result in a penalty recommendation.

Under K.A.R. 82-3-600, you must file an Application for Surface Pit (CDP-1) if you wish to use a workover pit while plugging the well. Failure to timely file a CDP-1, failure to timely remove fluids, or failure to timely file Closure of Surface Pit (CDP-4) or Waste Transfer (CDP-5) forms will result in a penalty recommendation.

This receipt does NOT constitute authorization to plug this well if you do not otherwise have the legal right to do so.

This receipt is VOID after February 11, 2016. If the well is not plugged by then, you will have to submit a new CP-1 if you wish to plug the well.

The February 11, 2016 deadline does NOT override any compliance deadline given to you by Legal, District, or other Commission Staff. Failure to comply with any given deadline will still result in the Commission assessing penalties, or taking other legal action.
