1. MIRUSU, Unflange well and NU BOP. Spot 2 3/8" work string and 3/4" rod string (2000').
2. PU overshot and TIH and latch parted tubing @ +/-1290'.
3. PU rod fishing tools and work string rods, TIH and latch parted rods. Attempt to unseat and/or back-off rods below 1700'.
4. RU wireline truck and cut tbg above freepoint and/or above rod fish. POH with tbg. Lay down junk tbg.
5. TIH with 2 3/8" workstring to top of fish and circulate hole with mud and spot 50 sacks Class "C" cement. POH and WOC. Tag TOC (minimum 50' above fish). Mix and spot 25 sacks cement, 1,500' -1,700' to cover anhydrite.
6. Pull up hole with tbg and set @ 634'; mix and pump 45 sacks Class "C" cement & circulate to surface. POH leave 4.5" full. RU to 8 5/8" casing outlet, fill with 10 sacks and pressure to 300 psi.
7. RDMOSU, Cut and cap well.

Dear Shawn Hildreth:

The Conservation Division has received your Well Plugging Application (CP-1).

Under K.A.R. 82-3-113(b)(2), you must notify DISTRICT 1 of your proposed plugging plan at least 5 days before plugging the well. DISTRICT 1's phone number is (620) 225-8888. Failure to notify DISTRICT 1, or failure to file a Well Plugging Record (CP-4) after the well is plugged will result in a penalty recommendation.

Under K.A.R. 82-3-600, you must file an Application for Surface Pit (CDP-1) if you wish to use a workover pit while plugging the well. Failure to timely file a CDP-1, failure to timely remove fluids, or failure to timely file Closure of Surface Pit (CDP-4) or Waste Transfer (CDP-5) forms will result in a penalty recommendation.

This receipt does NOT constitute authorization to plug this well if you do not otherwise have the legal right to do so.

This receipt is VOID after March 24, 2016. If the well is not plugged by then, you will have to submit a new CP-1 if you wish to plug the well.

The March 24, 2016 deadline does NOT override any compliance deadline given to you by Legal, District, or other Commission Staff. Failure to comply with any given deadline will still result in the Commission assessing penalties, or taking other legal action.
