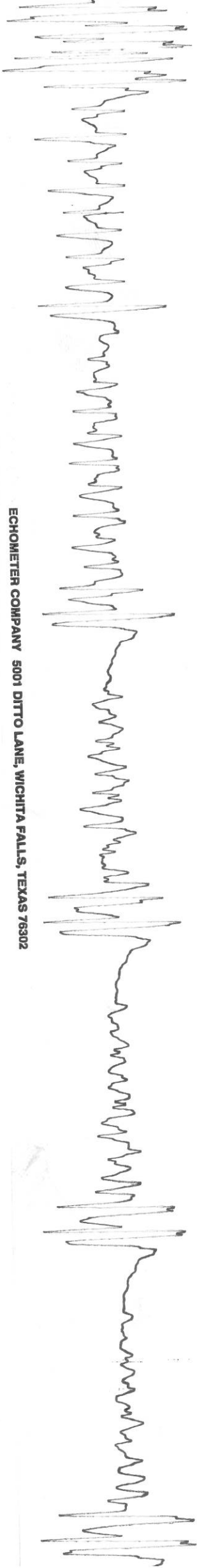

You must notify the Commission in writing no later than November 12, 2015 of your intention to file the application, and your complete application is due December 12, 2015.
