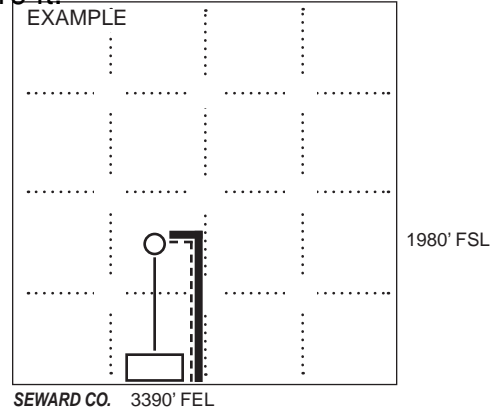

DIRECTIONS: From the North side of Holyrood, KS at the intersection of Hwy 156 and Ave. T - Now go 2.8 miles West on Ave. T - Now go 3 miles North on 2nd Rd. to the NE corner of section 30-16s-10w - Now go 0.5 mile West on Ave. Q to ingress stake South into - Now go 0.5 mile South on trail to ingress stake East into - Now go approx. 1020' East through terraced planted wheat to ingress stake North into - Now go 355' North through terraced planted wheat, into staked location.
