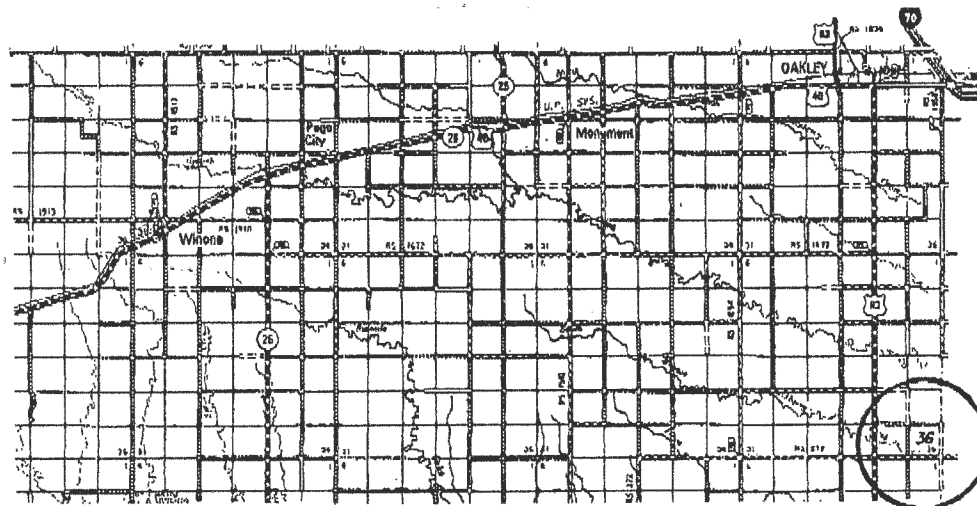
DIRT (TOPEKA RD.) ROAD

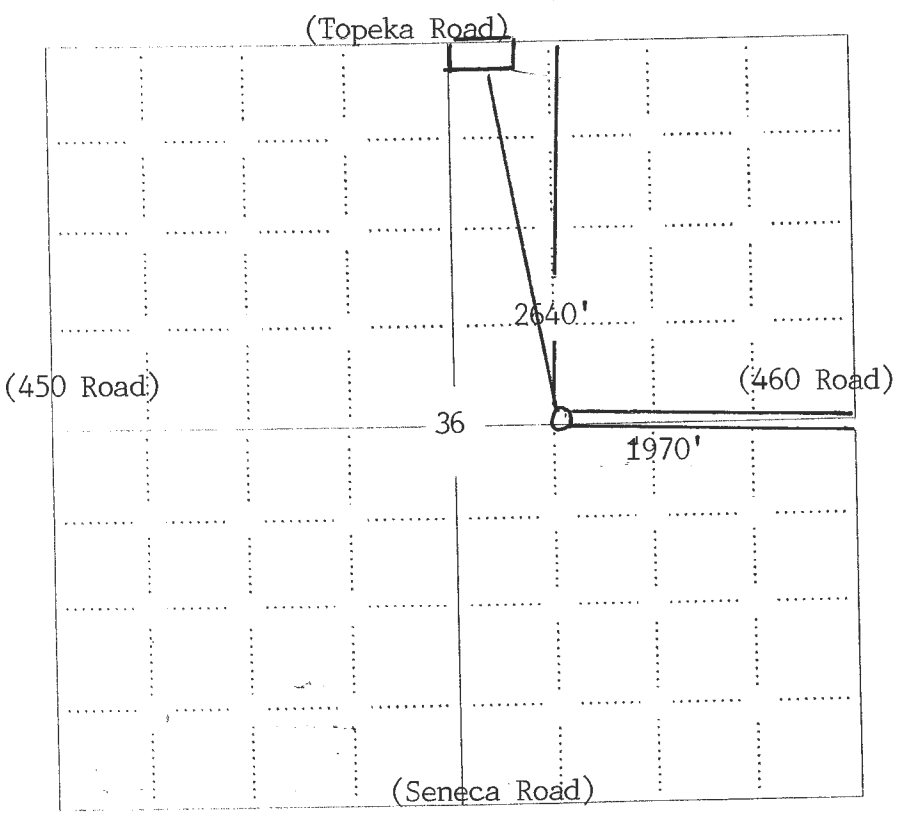

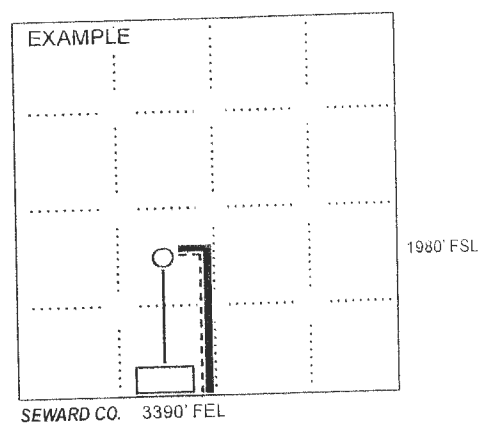
